- 22 (a) (1) Except as provided in subsection (n) of this section, a Class C beer,
- wine and liquor license shall be issued by the license issuing authority of the county in
- 24 which the place of business is located. It authorizes the holder to keep for sale and sell

- all alcoholic beverages at retail at any club, at the place described in the license, for 1 2 consumption on the premises only. 3 The annual fee for the license shall be paid to the local collecting agent before the license is issued, for distribution as provided. 4 In this section, "board" means the board of commissioners for the 5 6 jurisdiction to which the subsection applies. 7 (k) This subsection applies only in Dorchester County. (1) The annual license fee is \$1,000. 8 (2) 9 (6) (I)A license may be obtained by Sailwinds Park, Inc., a nonprofit organization. 10 11 The license may be obtained and renewed so long as no (II)individual or group of individuals derive any personal profits from the operation of the 12Park. 13 14 (III) WHEN ALCOHOLIC BEVERAGES ARE SERVED AT AN EVENT OPEN TO THE PUBLIC AT SAILWINDS PARK, INC., THE LICENSEE: 15 16 1. SHALL DISTRIBUTE AT THE EVENT A WRISTBAND 17 TO EACH INDIVIDUAL WHO IS AT LEAST 21 YEARS OLD; AND 2. 18 MAY NOT SERVE AN ALCOHOLIC BEVERAGE TO AN
- 19 INDIVIDUAL WHO DOES NOT WEAR THE WRISTBAND AT THE EVENT.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 July 1, 2012.
