A BILL ENTITLED

1 AN ACT concerning

2 **State Real Estate Commission – Sunset Extension and Program Evaluation**

3 FOR the purpose of continuing the State Real Estate Commission in accordance with
4 the provisions of the Maryland Program Evaluation Act (sunset law) by
5 extending to a certain date the termination provisions relating to certain
6 statutory and regulatory authority of the Commission; requiring the
7 Commission to include certain information in its annual report to the Secretary
8 of Labor, Licensing, and Regulation; increasing the amount that a person may
9 recover for each claim against the Real Estate Guaranty Fund; requiring the
10 licensee to submit notice of the change, certain documentation, and a certain fee
11 to the Commission if the address of the affiliated brokerage of a licensed
12 associate real estate broker or a licensed real estate salesperson changes;
13 increasing a certain fee for collection of a dishonored check; requiring the
14 Commission to submit a certain report on or before a certain date; and generally
15 relating to the State Real Estate Commission.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
4 MARYLAND, That the Laws of Maryland read as follows:

5 **Article – Business Occupations and Professions**

6 17–210.

7 The Commission shall submit to the Secretary an annual report of the activities
8 of the Commission that includes:

- 9 (1) a statement of the total receipts from license fees;
- 10 (2) a statement of the total expenditures of the Commission;
- 11 (3) the number of real estate broker licenses, associate real estate
12 broker licenses, and real estate salesperson licenses issued in each county;
- 13 (4) the number of hearings held;
- 14 (5) the number of complaints received;
- 15 (6) the number of investigations made;
- 16 (7) the number of applications for licenses denied;
- 17 (8) the total number of licenses suspended or revoked;
- 18 (9) the number of cases resolved within the schedule adopted under §
19 17–208(b) of this subtitle; [and]

20 **(10) THE NUMBER OF GUARANTY FUND AWARDS MADE THAT**
21 **REACH THE STATUTORY CAP AT THE TIME THE AWARD IS MADE, THE**
22 **CORRESPONDING AMOUNTS CLAIMED BY THE COMPLAINANT IN EACH CASE,**
23 **AND THE AMOUNT OF DAMAGES THAT WOULD HAVE BEEN REIMBURSABLE TO**
24 **THE COMPLAINANT IF THE STATUTORY CAP DID NOT EXIST; AND**

25 **[(10)] (11)** any other information that reflects the work of the
26 Commission.

28 (b) The amount recovered for any claim against the Guaranty Fund may not
29 exceed **[\$25,000] \$50,000** for each claim.

2 (a) Within the time set by the Commission, a real estate broker shall submit
3 to the Commission:

4 (1) written notice of any change in the address of the principal office of
5 the broker on the form that the Commission provides;

6 (2) the license certificate and pocket card of the broker; and

7 (3) a fee for issuance of a new license certificate and pocket card of \$5.

8 (b) On receipt of the notice, fee, license certificate, and pocket card, the
9 Commission shall issue a new license certificate and pocket card to the real estate
10 broker for the unexpired period of the broker's license.

11 (c) Within the time set by the Commission, a real estate broker shall submit
12 to the Commission:

13 (1) written notice of any change in the address of a branch office of the
14 broker on the form that the Commission provides;

15 (2) the branch office certificate; and

16 (3) a fee for the issuance of a new branch office certificate of \$5.

17 (d) On receipt of the notice, fee, and branch office certificate, the Commission
18 shall issue a new branch office certificate to the real estate broker for the unexpired
19 period of the branch office certificate.

20 (e) If a real estate broker changes the address of the principal office or a
21 branch office of the broker and fails to submit the required notice, the license of the
22 broker shall be suspended automatically until the broker submits the required notice.

23 **(F) IF THE ADDRESS OF THE AFFILIATED BROKERAGE OF A LICENSED**
24 **ASSOCIATE REAL ESTATE BROKER OR A LICENSED REAL ESTATE SALESPERSON**
25 **CHANGES, WITHIN THE TIME SET BY THE COMMISSION, THE LICENSEE SHALL**
26 **SUBMIT TO THE COMMISSION:**

27 **(1) WRITTEN NOTICE OF ANY CHANGE IN THE ADDRESS OF THE**
28 **BROKERAGE;**

29 **(2) THE LICENSE CERTIFICATE AND POCKET CARD OF THE**
30 **LICENSEE; AND**

1 **(3) A FEE FOR THE ISSUANCE OF A NEW LICENSE CERTIFICATE**
2 **AND POCKET CARD OF \$5.**

4 (a) If a person tenders a check to the Commission in payment of a fee and the
5 check is dishonored, the person shall pay to the Commission an additional fee for cost
6 of collection of [~~\$25~~] **\$35** for each dishonored check.

7 17-702.

8 Subject to the evaluation and reestablishment provisions of the Maryland
9 Program Evaluation Act, this title and all regulations adopted under this title shall
10 terminate and be of no effect after July 1, [2012] **2022**.

11 **Article – State Government**

12 8-403.

13 (a) On or before December 15 of the 2nd year before the evaluation date of a
14 governmental activity or unit, the Legislative Policy Committee, based on a
15 preliminary evaluation, may waive as unnecessary the evaluation required under this
16 section.

17 (b) Except as otherwise provided in subsection (a) of this section, on or before
18 the evaluation date for the following governmental activities or units, an evaluation
19 shall be made of the following governmental activities or units and the statutes and
20 regulations that relate to the governmental activities or units:

21 (60) Real Estate Commission, State (§ 17-201 of the Business
22 Occupations and Professions Article: July 1, [2011] **2021**);

23 **SECTION 2. AND BE IT FURTHER ENACTED**, That, on or before October 1,
24 2013, the State Real Estate Commission shall report to the Senate Education, Health,
25 and Environmental Affairs Committee and the House Economic Matters Committee,
26 in accordance with § 2-1246 of the State Government Article, on:

27 (1) the implementation of recommendations of the Department of
28 Legislative Services contained in the sunset evaluation report dated October 2010;

29 (2) any types of consumer claims that are not currently eligible for
30 restitution from the Real Estate Guaranty Fund, established under § 17-402 of the
31 Business Occupations and Professions Article, that the Commission believes should be
32 reimbursable under statute;

1 (3) if the Commission concludes that there is no need to expand the
2 types of claims eligible for restitution, whether the Commission recommends reducing,
3 suspending, or eliminating the Real Estate Guaranty Fund assessment; and

4 (4) the Commission's fiscal situation, including information on
5 licensing trends and operating expenses.

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 July 1, 2012.
