A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt – Maryland Consolidated Capital Bond Loan of 2012,**
3 **and the Maryland Consolidated Capital Bond Loans of 2005, 2006, 2007, 2008,**
4 **2009, 2010, and 2011**

5 FOR the purpose of authorizing the creation of a State Debt in the amount of One
6 Billion, One Hundred and Twelve Million, Eight Hundred and Eighty Thousand
7 (\$1,112,880,000), the proceeds to be used for certain necessary building,
8 construction, demolition, planning, renovation, conversion, replacement, and
9 capital equipment purchases of the State, for acquiring certain real estate in
10 connection therewith, and for grants to certain subdivisions and other
11 organizations for certain development and improvement purposes, subject to the
12 requirement that certain grantees provide and expend certain matching funds
13 by certain dates; providing generally for the issuance and sale of bonds
14 evidencing the loan; authorizing the creation of State Debt to be issued in 2013,
15 the proceeds to be used for certain purposes; authorizing the creation of State
16 Debt to be known as a Maryland Consolidated Preauthorization Act, to be
17 issued in 2014, the proceeds to be used for certain purposes; authorizing the
18 creation of State Debt to be known as a Maryland Consolidated
19 Preauthorization Act, to be issued in 2015, the proceeds to be used for certain
20 purposes; imposing a certain tax on all assessable property in the State;
21 requiring that certain grantees convey certain easements under certain
22 circumstances to the Maryland Historical Trust; providing that the proceeds of
23 certain loans must be expended or encumbered by a certain date; requiring
24 certain grantees to submit certain reports; authorizing certain unexpended
25 appropriations in certain prior capital budgets and bond loans to be expended
26 for other public projects; altering certain requirements for certain programs in
27 certain prior capital budgets and bond loans; providing that the authorizations
28 of State Debt in certain prior capital budgets and bond loans be reduced by
29 certain amounts; providing for certain additional information to be detailed
30 about each project in the capital program under certain circumstances;
31 requiring that certain projects be constructed at certain locations; repealing

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That:

12 (1) The Board of Public Works may borrow money and incur indebtedness on
13 behalf of the State of Maryland through a State loan to be known as the Maryland
14 Consolidated Capital Bond Loan of 2012 in the total principal amount of
15 \$1,112,880,000. This loan shall be evidenced by the issuance, sale, and delivery of
16 State general obligation bonds authorized by a resolution of the Board of Public Works
17 and issued, sold, and delivered in accordance with §§ 8–117 through 8–124 of the State
18 Finance and Procurement Article and Article 31, § 22 of the Code.

19 (2) The bonds to evidence this loan or installments of this loan may be sold
20 as a single issue of bonds under § 8–122 of the State Finance and Procurement Article.

21 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
22 and first shall be applied to the payment of the expenses of issuing, selling, and
23 delivering the bonds, unless funds for this purpose are otherwise provided, and then
24 shall be credited on the books of the Comptroller and expended, on approval by the
25 Board of Public Works, for the following public purposes, including any applicable
26 architects’ and engineers’ fees:
