- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 16 (a) Representation of an indigent individual may be provided in accordance 17 with this title by the Public Defender or, subject to the supervision of the Public 18 Defender, by the deputy public defender, district public defenders, assistant public
- defenders, or panel attorneys.
- 20 (b) (1) Indigent defendants or parties shall be provided representation 21 under this title in:
- 22 (i) a criminal or juvenile proceeding in which a defendant or 23 party is alleged to have committed a serious offense;

1 2 3	(ii) a criminal or juvenile proceeding in which an attorney is constitutionally required to be present prior to presentment being made before a commissioner or judge;
4 5	(iii) a postconviction proceeding for which the defendant has a right to an attorney under Title 7 of this article;

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
