- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:
- 14 Article Education
- 15 **4–127**.
- 16 (A) THIS SECTION APPLIES ONLY IN TALBOT COUNTY.
- 17 (B) A STUDENT WHO RESIDES IN THE GEOGRAPHICAL ATTENDANCE
- 18 AREA OF ONE PUBLIC SECONDARY SCHOOL IN THE COUNTY MAY PARTICIPATE
- 19 IN AN INTERSCHOLASTIC ATHLETIC ACTIVITY AT ANOTHER PUBLIC SECONDARY
- 20 SCHOOL IN THE COUNTY IF THAT ATHLETIC ACTIVITY IS NOT OFFERED AT THE
- 21 PUBLIC SECONDARY SCHOOL IN THE STUDENT'S GEOGRAPHICAL ATTENDANCE
- 22 AREA.

- 1 (C) THE STUDENT MAY PARTICIPATE IN THE ATHLETIC ACTIVITY
 2 WITHOUT TRANSFERRING FROM THAT ONE PUBLIC SECONDARY SCHOOL TO THE
 3 PUBLIC SECONDARY SCHOOL OUTSIDE THE STUDENT'S GEOGRAPHICAL
 4 ATTENDANCE AREA.
- 5 (D) A STUDENT'S PARTICIPATION IN AN INTERSCHOLASTIC ATHLETIC
 6 ACTIVITY AT ANOTHER PUBLIC SECONDARY SCHOOL IN THE COUNTY DOES NOT
 7 CHANGE THE CLASSIFICATION OF EITHER SCHOOL UNDER REGULATIONS AND
 8 POLICIES OF THE MARYLAND PUBLIC SECONDARY SCHOOLS ATHLETIC
 9 ASSOCIATION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2012.
