### 1 AN ACT concerning

## Education – Core Content Areas – Accountability Program

3 FOR the purpose of requiring the State Board of Education and the State 4 Superintendent of Schools to assist each county board of education to establish  $\mathbf{5}$ certain goals and objectives that conform with certain objectives for subject 6 areas that include science and social studies; requiring each public school to 7 survey current student achievement in science and social studies; requiring the 8 State Board and the State Superintendent to <del>design and</del> implement certain 9 assessment programs in certain subjects and requiring the social studies 10 assessment program programs to provide certain information and feedback;
