A BILL ENTITLED

1 AN ACT concerning

2 **Education – School Vehicle – On–Board Attendant**

3 FOR the purpose of prohibiting an individual from serving as a school vehicle
4 on–board attendant, unless the attendant is a certain employee and is in
5 possession of certain identification; authorizing the Motor Vehicle
6 Administration to adopt regulations concerning qualifications of school vehicle
7 on–board attendants with the advice of the State Department of Education; and
8 generally relating to school vehicle on–board attendants.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Transportation**

17 16–816.

18 (a) An individual may not drive a school vehicle on any highway in this State
19 unless the individual:

20 (1) Passes an appropriate medical examination; and

21 (2) For driving a school bus, has been issued a commercial driver’s
22 license endorsed school bus.

1 **(B) AN INDIVIDUAL MAY NOT SERVE AS A SCHOOL VEHICLE ON-BOARD**
2 **ATTENDANT UNLESS THE INDIVIDUAL:**

3 **(1) IS AN EMPLOYEE OF THE LOCAL SCHOOL SYSTEM OR**
4 **TRANSPORTATION COMPANY THAT OPERATES THE SCHOOL VEHICLE; AND**

5 **(2) IS IN POSSESSION OF PHOTO IDENTIFICATION THAT**
6 **IDENTIFIES THE LOCAL SCHOOL SYSTEM OR TRANSPORTATION COMPANY THAT**
7 **EMPLOYS THE INDIVIDUAL AS A SCHOOL VEHICLE ON-BOARD ATTENDANT.**

8 **[(b)] (C)** With the advice of the State Department of Education, the
9 Administration may adopt regulations concerning the qualifications of school vehicle
10 drivers **AND SCHOOL VEHICLE ON-BOARD ATTENDANTS.**

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2012.
