2 (a) (2) (i) Notwithstanding any other provision of law, and unless 3 inconsistent with a federal law, grant agreement, or other federal requirement or with 4 the terms of a gift or settlement agreement, net interest on all State money allocated 5 by the State Treasurer under this section to special funds or accounts, and otherwise 6 entitled to receive interest earnings, as accounted for by the Comptroller, shall accrue 7 to the General Fund of the State.
