## Town of Ocean City – Criminal History Records Check – Taxi Driver Applicants

- FOR the purpose of authorizing the Ocean City Police Department to request State 4 and national criminal history records checks for taxi driver applicants in Ocean 5 6 City from the Criminal Justice Information System Central Repository; 7 requiring the Police Department to submit sets of fingerprints of taxi driver applicants and pay certain fees to the Central Repository as part of the 8 9 application for a records check; requiring the Central Repository to forward 10 certain information to certain persons; specifying that certain information be 11 confidential, not be redisseminated, and be used only for a certain purpose; 12 authorizing the subject of a criminal history records check to contest the 13 contents of a certain statement in a certain manner; and generally relating to criminal history records checks for taxi driver applicants in Ocean City. 14
