1 AN ACT concerning

Frederick County – Alcoholic Beverages – Follow–Up Criminal History Records Checks

- FOR the purpose of requiring the Criminal Justice Information System Central 4 $\mathbf{5}$ Repository of the Department of Public Safety and Correctional Services to 6 provide the Board of License Commissioners of Frederick County with a revised 7 printed criminal record statement of a license applicant or license holder if 8 information is reported to the Central Repository after the initial criminal 9 history records check is completed; requiring the Central Repository to stop providing the Board with revised printed statements under certain 10 circumstances; and generally relating to alcoholic beverages licenses in 11 12Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 19 MARYLAND, That the Laws of Maryland read as follows:

Article 2B – Alcoholic Beverages

(b) Except as otherwise provided in this subtitle, every new application for a license shall be made to the Board of License Commissioners on forms prescribed by the Comptroller and sworn to by the applicant. Every application for a license shall contain the following:

IF THE BOARD OF LICENSE COMMISSIONERS INFORMS THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES THAT AN INDIVIDUAL IS NO LONGER AN APPLICANT OR LICENSE HOLDER, THE CENTRAL REPOSITORY SHALL STOP PROVIDING THE BOARD WITH REVISED PRINTED STATEMENTS OF THE CRIMINAL RECORD OF THE INDIVIDUAL.
