- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

- 18 (c) (1) (i) Individual health insurance coverage and health insurance 19 coverage offered in the small group and large group markets, as those terms are
- 20 defined in the federal Public Health Service Act, issued or delivered in the State by an
- 21 authorized insurer, nonprofit health service plan, or health maintenance organization
- shall comply with the loss ratio requirements of sections 1001(5) and 10101(f) of the
- 23 Affordable Care Act, which amend section 2718 of the Public Health Service Act.

- 1 (iii) The Commissioner may require an insurer, a nonprofit 2 health service plan, or a health maintenance organization to file new rates if the loss 3 ratio reported in the manner required under 45 C.F.R. § 158 is less than that required 4 under subparagraph (i) of this paragraph.
 - (2) The authority of the Commissioner under paragraph (1) of this subsection to require an insurer, nonprofit health service plan, or health maintenance organization to file new rates based on loss ratio:
- 8 (i) is in addition to any other authority of the Commissioner 9 under this article to require that rates not be excessive, inadequate, or unfairly 10 discriminatory; and
- 11 (ii) does not limit any existing authority of the Commissioner to determine whether a rate is excessive.

- 28 (6) Any rebate received by a managed care organization may not be considered part of the loss ratio of the managed care organization.

- 6 (I) THE LOSS RATIO, AS DETERMINED BY THE
 7 DEPARTMENT OF HEALTH AND MENTAL HYGIENE FOR EACH MANAGED CARE
 8 ORGANIZATION PARTICIPATING IN THE MEDICAL ASSISTANCE PROGRAM, FOR

 REQUIREMENT UNDER PARAGRAPH (4) OF THIS SUBSECTION; AND
- 14 (III) ANY AMOUNT DUE TO OR RECEIVED BY THE 15 DEPARTMENT OF HEALTH AND MENTAL HYGIENE FROM A MANAGED CARE 16 ORGANIZATION FOR EACH YEAR DURING THE 3-YEAR PERIOD.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2012.
