11 (a) (1) (i) If a provider's feasibility study has been approved under § 12 10–409 of this subtitle, the Department, within 120 days after receipt of a continuing 13 care agreement or any other related agreement submitted by a provider, shall 14 determine whether the agreement complies with the requirements of this subtitle.

34 SECTION 3. AND BE IT FURTHER ENACTED, That if any provision of this 35 Act or the application thereof to any person or circumstance is held invalid for any

1 reason in a court of competent jurisdiction, the invalidity does not affect other 2 provisions or any other application of this Act which can be given effect without the 3 invalid provision or application, and for this purpose the provisions of this Act are 4 declared severable.
