4 FOR the purpose of ~~requiring the Division of Library Development and Services in the~~
5 ~~State Department of Education to establish and coordinate the Maryland Deaf~~
6 ~~Culture Digital Library; requiring the Division to coordinate with the~~
7 ~~Governor's Office of the Deaf and Hard of Hearing in establishing the digital~~
8 ~~library; specifying a certain purpose and content of the digital library~~ creating
9 the Task Force to Study the Establishment of a Deaf Culture Digital Library;
10 providing for the composition, chair, and staffing of the Task Force; prohibiting
11 a member of the Task Force from receiving certain compensation, but
12 authorizing the reimbursement of certain expenses; requiring the Task Force to
13 study and make recommendations regarding certain matters; requiring the
14 Task Force to report its findings and recommendations to the Governor and the
15 General Assembly on or before a certain date; providing for the termination of
16 this Act; and generally relating to the establishment of the Maryland Task
17 Force to Study the Establishment of a Deaf Culture Digital Library.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

5 ~~(a) In addition to any other powers granted and duties imposed by this title,~~
6 ~~and subject to the authority of the State Board, the Division of Library Development~~
7 ~~and Services has the powers and duties set forth in this section.~~

8 ~~(b) The Division of Library Development and Services shall:~~

9 ~~(1) Provide leadership and guidance for the planning and coordinated~~
10 ~~development of library and information service in this State;~~

11 ~~(2) Develop statewide public and school library services and networks,~~
12 ~~resource centers, and other arrangements to meet the library and information needs of~~

14 ~~(3) Provide professional and technical advice on improving library~~

9 ~~capital projects, in accordance with § 23-510 of this title;~~

10 ~~(10) Adopt guidelines for the administration of public libraries and~~
11 ~~recommend to the State Board rules and regulations to implement this title;~~

12 ~~(11) Cooperate with national library agencies and those of any other~~

14 ~~(12) (i) ESTABLISH THE MARYLAND DEAF CULTURE DIGITAL~~
15 ~~LIBRARY IN COORDINATION WITH THE GOVERNOR'S OFFICE OF THE DEAF AND~~
16 ~~HARD OF HEARING; AND~~

17 ~~(ii) COORDINATE THE MARYLAND DEAF CULTURE DIGITAL~~
18 ~~LIBRARY TO EDUCATE INDIVIDUALS ABOUT DEAF CULTURES IN THE UNITED~~
19 ~~STATES AND OTHER COUNTRIES, WHICH SHALL INCLUDE:~~

20 ~~1. REFERENCE MATERIAL; AND~~

21 ~~2. LINKS TO OTHER RESOURCES; AND~~

22 ~~[(12)] (13) Perform any other duty necessary for its proper operation.~~

23 (a) There is a Task Force to Study the Establishment of a Deaf Culture
24 Library.

25 (b) The Task Force consists of the following 11 members:

26 (1) two members of the Senate of Maryland, appointed by the
27 President of the Senate;

28 (2) two members of the House of Delegates, appointed by the Speaker
29 of the House;

1 (3) the State Superintendent of Education, or the State
2 Superintendent's designee; and

3 (4) the following six members, appointed by the Governor:

4 (i) one representative of the Division of Library Development
5 and Services in the State Department of Education;

6 (ii) one representative of the Governor's Office of the Deaf and
7 Hard of Hearing;

8 (iii) one representative of the Maryland Library Association; and

9 (iv) three representatives of the deaf community or of deaf
10 organizations in the State.

11 (c) The Governor shall designate the chair of the Task Force.

12 (d) The State Department of Education shall provide staff for the Task Force.

13 (e) A member of the Task Force:

14 (1) may not receive compensation as a member of the Task Force; but

15 (2) is entitled to reimbursement for expenses under the Standard
16 State Travel Regulations, as provided in the State budget.

17 (f) The Task Force shall:

18 (1) study the establishment of a Deaf Culture Digital Library,
19 including potential funding sources for the library through a public-private
20 partnership or the establishment of a friends of the library organization; and

21 (2) make recommendations regarding the coordination of a Deaf
22 Culture Digital Library to educate individuals about deaf cultures in the United
23 States and other countries, including reference material and links to other resources.

24 (g) On or before December 1, 2012, the Task Force shall report its findings
25 and recommendations to the Governor and, in accordance with § 2-1246 of the State
26 Government Article, the General Assembly.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
28 ~~October~~ July 1, 2012. It shall remain effective for a period of 1 year and, at the end of
29 June 30, 2013, with no further action required by the General Assembly, this Act shall
30 be abrogated and of no further force and effect.
