### 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That the Laws of Maryland read as follows:

### Article – State Government

17 10–618.

18 (d) (1) Subject to paragraph (2) of this subsection, a custodian may deny 19 inspection of a public record that contains the specific details of a research project that 20 an institution of the State or of a political subdivision is conducting.

21 (2) A custodian may not deny inspection of the part of a public record 22 that gives only the name, title, expenditures, and date when the final project summary 23 will be available.
