$\frac{24}{25}$	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 2 (b) "Apprentice natural gas fitter" means, unless the context requires otherwise, an individual who is licensed by the Board to assist a master natural gas fitter in providing natural gas services while:
- 5 (1) under the direction and control of the master natural gas fitter; 6 and
- 7 (2) in training to become a journeyman natural gas fitter.
- 8 (c) "Apprentice plumber" means, unless the context requires otherwise, an 9 individual who is licensed by the Board to assist a master plumber or a holder of a 10 limited master plumber license in providing plumbing services while:
- 11 (1) under the direction and control of the master plumber or holder of 12 the limited master plumber license; and
- 13 (2) in training to become a journey plumber.

- 15 (c) While an apprentice plumber license is in effect, it authorizes the licensee 16 to assist in providing plumbing services only under the direction and control of a 17 master plumber or a holder of a limited master plumber license.
- 18 (g) While an apprentice natural gas fitters license is in effect, it authorizes 19 the licensee to provide natural gas service only under the direction and control of a 20 licensed master natural gas fitter.

- 28 (A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, FOR AN 29 APPRENTICE PLUMBER OR APPRENTICE NATURAL GAS FITTER ISSUED AN 30 INITIAL LICENSE ON OR AFTER OCTOBER 1, 2012, THE BOARD MAY NOT RENEW

- 1 THE LICENSE FOR MORE THAN THREE CONSECUTIVE TERMS IF THE LICENSEE
- 2 HAS NOT TAKEN OR REGISTERED TO TAKE A JOURNEY PLUMBER EXAMINATION
- 3 OR JOURNEYMAN GAS FITTERS EXAMINATION.
- 4 (B) NOTWITHSTANDING SUBSECTION (A) OF THIS SECTION, IF AN 5 APPRENTICE PLUMBER OR APPRENTICE NATURAL GAS FITTER FAILS A 6 **PLUMBER EXAMINATION** \mathbf{OR} **JOURNEYMAN** GAS **JOURNEY** 7 EXAMINATION, THE BOARD MAY RENEW THE APPRENTICE PLUMBER LICENSE 8 OR APPRENTICE NATURAL GAS FITTERS LICENSE FOR AN ADDITIONAL 2-YEAR
- 9 TERM FOR EACH FAILED EXAMINATION.
