2 State Board of Physicians – Sunset Extension and Program Evaluation

3 FOR the purpose of continuing the State Board of Physicians in accordance with the 4 provisions of the Maryland Program Evaluation Act (Sunset Law) by extending $\mathbf{5}$ to a certain date the termination provisions relating to the statutory and 6 regulatory authority of the Board; prohibiting certain individuals from 7providing certain services to the Board under certain circumstances; prohibiting 8 certain individuals from being appointed to the Board under certain 9 circumstances; repealing a certain provision of law regarding entry onto private 10 premises for a certain purpose; authorizing the Board's executive director to 11 apply for a certain search warrant under certain circumstances; specifying that 12the application for the warrant must meet certain requirements; authorizing a 13judge who receives a certain search warrant application to issue a warrant 14under certain circumstances; specifying that a certain search warrant must 15include certain information and be executed and returned to a certain person 16 within a certain period of time; authorizing certain physicians to practice 17medicine without a license under certain circumstances; providing for a certain 18exception to certain education qualifications necessary for licensure; codifying 19the requirement that the Board provide certain individuals an opportunity to 20appear before the Board under certain circumstances; requiring the Board to 21disclose the filing of charges and initial denials of licensure on the Board's Web 22site; requiring that physician license profiles include a summary of charges filed 23against the physician and a copy of the charging document under certain 24circumstances; requiring that license profiles include a certain disclaimer;
