1 AN ACT concerning

2 **Public Safety – Possession of Firearms – Crimes Committed in Other States**

3 FOR the purpose of prohibiting a person from possessing a regulated firearm, rifle, or
4 shotgun if the person was previously convicted of an offense under the laws of
5 another state or the United States that would constitute a certain crime if
6 committed in this State; and generally relating to restrictions on possession of a
7 regulated firearm, rifle, or shotgun.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Public Safety**

16 5–133.

17 (c) (1) A person may not possess a regulated firearm if the person was
18 previously convicted of:

19 (i) a crime of violence; [or]

7 (a) A person may not possess a rifle or shotgun if the person was previously
8 convicted of:

9 (1) a crime of violence; [or]

10 (2) a violation of § 5-602, § 5-603, § 5-604, § 5-605, § 5-612, § 5-613,
11 or § 5-614 of the Criminal Law Article; **OR**

12 **(3) AN OFFENSE UNDER THE LAWS OF ANOTHER STATE OR THE**
13 **UNITED STATES THAT WOULD CONSTITUTE ONE OF THE CRIMES LISTED IN ITEM**
14 **(1) OR (2) OF THIS SUBSECTION IF COMMITTED IN THIS STATE.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2012.
