Environment – Asbestos Worker Protection

- 3 FOR the purpose of adding to the General Assembly's findings related to protecting 4 the safety of asbestos removers; requiring the Department of the Environment 5 to verify certain information before accrediting an individual to engage in an 6 asbestos occupation; authorizing the Department to include the costs of 7 examination administration in setting certain fees; altering the circumstances 8 under which a certain penalty may be composed; increasing the maximum 9 penalty that may be imposed for certain violations; establishing a minimum 10 penalty under a certain circumstance; requiring certain penalties and fines to 11 be paid into the Asbestos Worker Protection Fund and providing for the uses of 12 the Fund; establishing the Fund as a special, nonlapsing fund; requiring the 13 Department to administer the Fund; requiring the State Treasurer to hold the 14 Fund and the Comptroller to account for the Fund; specifying the contents of 15 the Fund; providing for the investment of money in and expenditures from the 16 Fund; exempting certain interest earnings from a requirement that certain 17 interest accrue to the General Fund; altering the definition of a certain term; 18 defining a certain term; and generally relating to asbestos worker protection.
