State Personnel Management System - Criminal History Records Check

3 FOR the purpose of authorizing certain appointing authorities in the State Personnel 4 Management System to request from the Criminal Justice Information System 5 Central Repository State and national criminal history records checks for 6 certain prospective and current employees; establishing certain procedures to 7 apply for a criminal history records check; requiring the Central Repository to 8 forward criminal history record information to the current or prospective 9 employee under certain circumstances; providing that certain information is 10 confidential and may be used only for certain purposes; authorizing a person 11 who is the subject of a criminal history records check under this Act to contest 12 certain information in the record; authorizing the Secretary of Budget and Management to adopt certain regulations, guidelines, and policies to implement 13 this Act; defining a certain term; and generally relating to State and national 14 15 criminal history records checks for certain prospective and current employees in 16 the State Personnel Management System.

- 22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 1 (A) IN THIS SECTION, "CENTRAL REPOSITORY" MEANS THE CRIMINAL 2 JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT 3 OF PUBLIC SAFETY AND CORRECTIONAL SERVICES.
- 4 (B) (1) AN APPOINTING AUTHORITY MAY REQUEST A STATE AND 5 NATIONAL CRIMINAL HISTORY RECORDS CHECK FROM THE CENTRAL 6 REPOSITORY FOR:
- 7 (I) A PERSON WHO IS SELECTED FOR A POSITION IN THE 8 STATE PERSONNEL MANAGEMENT SYSTEM; OR
- 9 (II) A CURRENT EMPLOYEE WHO IS ELIGIBLE AND IS BEING 10 RECOMMENDED FOR TRANSFER, PROMOTION, OR REASSIGNMENT TO A 11 POSITION IN THE STATE PERSONNEL MANAGEMENT SYSTEM.
- 12 (2) THE APPOINTING AUTHORITY SHALL APPLY TO THE CENTRAL
 13 REPOSITORY FOR A STATE AND NATIONAL CRIMINAL HISTORY RECORDS CHECK
 14 FOR EACH PROSPECTIVE OR CURRENT EMPLOYEE FOR WHOM A RECORDS
 15 CHECK IS SOUGHT UNDER PARAGRAPH (1) OF THIS SUBSECTION.
- 16 (3) AS PART OF THE APPLICATION FOR A CRIMINAL HISTORY
 17 RECORDS CHECK, THE APPOINTING AUTHORITY SHALL SUBMIT TO THE
 18 CENTRAL REPOSITORY:
- (I) TWO COMPLETE SETS OF THE PROSPECTIVE OR
 CURRENT EMPLOYEE'S LEGIBLE FINGERPRINTS TAKEN IN A FORMAT APPROVED
 BY THE DIRECTOR OF THE CENTRAL REPOSITORY AND THE DIRECTOR OF THE
 FEDERAL BUREAU OF INVESTIGATION;
- 23 (II) THE FEE AUTHORIZED UNDER § 10–221(B)(7) OF THE CRIMINAL PROCEDURE ARTICLE FOR ACCESS TO CRIMINAL HISTORY RECORD INFORMATION; AND
- 26 (III) THE MANDATORY PROCESSING FEE REQUIRED BY THE FEDERAL BUREAU OF INVESTIGATION FOR A NATIONAL CRIMINAL HISTORY RECORDS CHECK.
- 29 (4) IN ACCORDANCE WITH TITLE 10, SUBTITLE 2 OF THE 30 CRIMINAL PROCEDURE ARTICLE, THE CENTRAL REPOSITORY SHALL FORWARD 31 TO THE PROSPECTIVE OR CURRENT EMPLOYEE AND THE APPOINTING 32 AUTHORITY THE PROSPECTIVE OR CURRENT EMPLOYEE'S CRIMINAL HISTORY 33 RECORD INFORMATION.

7	(C) A PERSON WHO IS THE SUBJECT OF A CRIMINAL HISTORY RECORDS
8	CHECK UNDER THIS SECTION MAY CONTEST THE CONTENTS OF THE PRINTED
9	STATEMENT ISSUED BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10-223
10	OF THE CRIMINAL PROCEDURE ARTICLE.
11	(D) THE SECRETARY MAY ADOPT REGULATIONS, GUIDELINES, AND
12	POLICIES TO CARRY OUT THIS SECTION.
13	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14	July 1, 2012.
