### A BILL ENTITLED

#### 1 AN ACT concerning

# 2 Creation of a State Debt – Frederick County – Mental Health Association 3 Building

4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$300,000,  $\mathbf{5}$ the proceeds to be used as a grant to the Board of Directors of the Mental 6 Health Association of Frederick County, Inc. for certain development or 7 improvement purposes; providing for disbursement of the loan proceeds, subject 8 to a requirement that the grantee provide and expend a matching fund; 9 establishing a deadline for the encumbrance or expenditure of the loan proceeds: and providing generally for the issuance and sale of bonds evidencing 10 the loan. 11

#### 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That:

14The Board of Public Works may borrow money and incur indebtedness on (1)behalf of the State of Maryland through a State loan to be known as the Frederick 15County – Mental Health Association Building Loan of 2012 in a total principal amount 16 17equal to the lesser of (i) \$300,000 or (ii) the amount of the matching fund provided in 18 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale, 19and delivery of State general obligation bonds authorized by a resolution of the Board 20of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through 218–124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.

(2) The bonds to evidence this loan or installments of this loan may be sold
as a single issue or may be consolidated and sold as part of a single issue of bonds
under § 8–122 of the State Finance and Procurement Article.

25 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer 26 and first shall be applied to the payment of the expenses of issuing, selling, and 27 delivering the bonds, unless funds for this purpose are otherwise provided, and then

1 shall be credited on the books of the Comptroller and expended, on approval by the 2 Board of Public Works, for the following public purposes, including any applicable 3 architects' and engineers' fees: as a grant to the Board of Directors of the Mental 4 Health Association of Frederick County, Inc. (referred to hereafter in this Act as "the 5 grantee") for the renovation of the Mental Health Association Building, located in 6 Frederick.

7 (4) An annual State tax is imposed on all assessable property in the State in 8 rate and amount sufficient to pay the principal of and interest on the bonds, as and 9 when due and until paid in full. The principal shall be discharged within 15 years 10 after the date of issuance of the bonds.

11 Prior to the payment of any funds under the provisions of this Act for the (5)12purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching fund. No part of the grantee's matching fund may be provided, either 1314directly or indirectly, from funds of the State, whether appropriated or 15unappropriated. No part of the fund may consist of real property. The fund may 16consist of in kind contributions or funds expended prior to the effective date of this 17Act. In case of any dispute as to the amount of the matching fund or what money or assets may qualify as matching funds, the Board of Public Works shall determine the 1819matter and the Board's decision is final. The grantee has until June 1, 2014, to present 20evidence satisfactory to the Board of Public Works that a matching fund will be provided. If satisfactory evidence is presented, the Board shall certify this fact and the 2122amount of the matching fund to the State Treasurer, and the proceeds of the loan 23equal to the amount of the matching fund shall be expended for the purposes provided 24in this Act. Any amount of the loan in excess of the amount of the matching fund 25certified by the Board of Public Works shall be canceled and be of no further effect.

(6) The proceeds of the loan must be expended or encumbered by the Board
of Public Works for the purposes provided in this Act no later than June 1, 2019. If any
funds authorized by this Act remain unexpended or unencumbered after June 1, 2019,
the amount of the unencumbered or unexpended authorization shall be canceled and
be of no further effect. If bonds have been issued for the loan, the amount of
unexpended or unencumbered bond proceeds shall be disposed of as provided in
§ 8–129 of the State Finance and Procurement Article.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 34 June 1, 2012.
