# 2 Harford County Board of Education – Student Member–Voting Rights

FOR the purpose of providing that the student member of the Harford County Board
of Education has certain rights and privileges; prohibiting the student member
from voting on or participating in certain matters; making a certain technical
change providing that certain provisions of law relating to the payment of
certain expenses for members of the Harford County Board of Education do not
apply to the student member of the Board; making certain clarifying changes;
altering a certain definition; and generally relating to the Harford County
