#### $\mathbf{2}$ Maryland Transportation Authority - Audits - Statements Available Online

- 3 FOR the purpose of requiring the Maryland Transportation Authority or an entity 4 engaged by the Authority to annually audit the finances of each transportation  $\mathbf{5}$ facilities project; requiring the Authority to make certain audit statements 6 available on its Internet site in a certain manner; defining a certain term; and 7 generally relating to requiring audits and online posting of audit statements of 8 the Maryland Transportation Authority.
