Real Property – Condominiums and Homeowners Associations – Abandoned Property

FOR the purpose of authorizing the governing body of a condominium or homeowners 4 $\mathbf{5}$ association to send a mortgagee certain notice that the property subject to the 6 mortgage in the condominium or homeowners association has been deemed 7 abandoned; providing that within a certain time period any fines, fees, 8 assessments, or obligations owed to the governing body of the condominium or 9 homeowners association in connection with the abandoned property shall have first lien priority under certain circumstances; defining certain terms; and 10 generally relating to abandoned property in a condominium or homeowners 11 12association.
