# State Lottery Agency – Veterans Lottery – Established

- FOR the purpose of requiring the State Lottery Agency to conduct a certain annual
  lottery for the benefit of the Maryland Veterans Trust Fund; requiring the
  Agency to deposit into the Fund a percentage of the proceeds, after certain
  expenses of the veterans lottery; requiring the Agency to meet certain
  advertising criteria in conducting the veterans lottery; and generally relating to
  lotteries conducted by the State Lottery Agency.

DISTRIBUTION UNDER SUBSECTION (A) OF THIS SECTION; AND

18 [(ii)] (III) into the General Fund of the State the money that 19 remains in the State Lottery Fund from the proceeds of all other lotteries after the 20 distribution under subsection (a) of this section.
