# A BILL ENTITLED

1 AN ACT concerning

## 2 Public Safety - Department of State Police - Yellow Dot Program

3 FOR the purpose of establishing the Yellow Dot Program in the Department of State 4 Police in order to provide a means to alert emergency responders to  $\mathbf{5}$ health-related information in the event a Program participant is involved in a 6 vehicle emergency and is unable to communicate; providing that a Program 7 participant, by affixing a yellow dot decal to a vehicle, consents to a certain 8 search of the vehicle's glove compartment or glove box by emergency responders 9 under certain circumstances; requiring the Department to design and make available certain materials necessary to implement and administer the 10 Program: requiring the Department to publicize the Program and distribute 11 12Program materials in cooperation with the Motor Vehicle Administration; and generally relating to the Yellow Dot Program. 13

5 (B) IN COOPERATION WITH THE MOTOR VEHICLE ADMINISTRATION, 6 THE DEPARTMENT SHALL PUBLICIZE THE PROGRAM AND DISTRIBUTE 7 PROGRAM MATERIALS.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2012.
