 certificate of title for the deceased's vehicle if the new certificate of title is issued
 to certain persons; and generally relating to Administration fees for the
 issuance of a certificate of title for a vehicle.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

- 15 Article Transportation
- 16 13–801.

17 [The] **ANY APPLICABLE** fees specified in this part for a certificate of title shall 18 be paid to the Administration before issuance of the certificate.

- 20 (a) Except as provided in subsection (b) of this section and § 13–805 of this 21 subtitle, the fee for each certificate of title issued under this title is \$100.

1 (b) (1) For fiscal years 2012 through 2014 only, the fee for each certificate 2 of title issued for a rental vehicle is \$50.

3 (2) IF A SOLE OR JOINT OWNER OF A VEHICLE DIES AND THE
4 VEHICLE IS SUBSEQUENTLY TRANSFERRED TO ANOTHER PERSON, THE
5 ADMINISTRATION MAY NOT REQUIRE THE PERSON TO PAY A FEE FOR THE
6 ISSUANCE OF A NEW CERTIFICATE OF TITLE FOR THE VEHICLE IF:

7 (I) IN THE CASE OF A VEHICLE THAT WAS SOLELY OWNED 8 BY THE DECEASED, THE PERSON IS:

9 **1.** A MEMBER OF THE IMMEDIATE FAMILY OF THE 10 DECEASED; OR

112. AN HEIR WHO INHERITED THE VEHICLE IN12ACCORDANCE WITH THE WILL OF THE DECEASED; OR

(II) IN THE CASE OF A VEHICLE THAT WAS JOINTLY OWNED,
THE PERSON IS ANOTHER JOINT OWNER OF THE VEHICLE WHO TOOK
OWNERSHIP OF THE VEHICLE THROUGH RIGHT OF SURVIVORSHIP.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2012.
