FISCAL AND POLICY NOTE

House Bill 124

(Frederick County Delegation)

Appropriations

Budget and Taxation

Frederick County - Public Facilities Bonds

This bill authorizes the Frederick County Commissioners to issue up to \$100.0 million in general obligation bonds in order to finance the cost of specified public facilities in the county. The date of maturity of the bonds cannot exceed 30 years.

The bill takes effect June 1, 2012.

Fiscal Summary

State Effect: None.

Local Effect: Frederick County receives up to \$100.0 million in bond proceeds. County debt service expenditures increase by an estimated \$6.6 million annually over a 20-year period.

Small Business Effect: None.

Analysis

Current Law: Commission counties do not have the legislative power to create debt; General Assembly authorization is required before any bonds can be sold. Frederick County is one of eight counties that still operate under the commission form of government.

Background: Since 2001, Frederick County has received authorization by the General Assembly to issue up to \$330.0 million in general obligation bonds for public facilities, as shown in **Exhibit 1**. A detailed listing of projects included in the Frederick County *Capital Improvement Program* (CIP) for fiscal 2012 through 2017 is shown in **Exhibit 2**.

Local Fiscal Effect: Frederick County revenues increase by up to \$100.0 million from bond proceeds. Annual debt service costs for the bonds total approximately \$6.6 million. This estimate is based on a 2.96% interest rate and a 20-year term of maturity. To the extent that the bond issuance, interest rate, or term of maturity deviate from this assumption, expenditures would adjust accordingly.

At the end of fiscal 2011, Frederick County had approximately \$274.0 million in total net general obligation debt outstanding, which represented a \$18.9 million decrease over the prior year. The outstanding debt represented 1.02% of the county's assessable base and \$1,164 on a per capita basis. In fiscal 2011, the county was assigned a AA+ rating by Standard and Poor's, and has an Aa1 credit rating from Moody's Investors Service, and an AAA rating from Fitch Ratings.
