(3) IS NO LONGER UNDER THE JURISDICTION OF THE DEPARTMENT.

SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 31, 2013, the Department of Public Safety and Correctional Services shall report to the Governor and, subject to § 2-1246 of the State Government Article, the General Assembly on the number of certificates of completion issued under this Act.

<u>SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be</u> <u>construed prospectively to apply only to individuals under the supervision of the</u> <u>Department of Public Safety and Correctional Services on or after July 1, 2013.</u>".
