1 AN ACT concerning

2 **Queen Anne’s County – Beer, Wine and Liquor Tasting License**

3 FOR the purpose of creating in Queen Anne’s County a beer, wine and liquor tasting
4 license; specifying to whom the license may be issued; setting maximum limits
5 on the amounts of certain individual servings; specifying that the license may be
6 issued for tasting purposes only; establishing a license fee; and generally
7 relating to alcoholic beverages licenses in Queen Anne’s County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That Section(s) 8–410.2 and 8–410.3, respectively, of Article
21 2B – Alcoholic Beverages of the Annotated Code of Maryland be renumbered to be
22 Section(s) 8–410.3 and 8–410.4, respectively.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
2 read as follows:

3 **Article 2B – Alcoholic Beverages**

4 **8-410.2.**

5 (A) THIS SECTION APPLIES ONLY IN QUEEN ANNE’S COUNTY.

6 (B) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A BEER, WINE
7 AND LIQUOR TASTING (BWLTL) LICENSE.

8 (C) A BWLTL LICENSE MAY BE ISSUED ONLY TO A HOLDER OF A CLASS
9 A BEER, WINE AND LIQUOR LICENSE.

10 (D) (1) A BWLTL LICENSE AUTHORIZES THE CONSUMPTION FOR
11 TASTING PURPOSES ONLY OF:

12 (I) NOT MORE THAN 1 OUNCE OF BEER FROM EACH GIVEN
13 BRAND AND 4 OUNCES FROM ALL BRANDS;

14 (II) NOT MORE THAN 2 OUNCES OF WINE FROM EACH GIVEN
15 BRAND AND 4 OUNCES FROM ALL BRANDS; AND

16 (III) NOT MORE THAN ONE-HALF OUNCE OF LIQUOR FROM
17 EACH GIVEN BRAND AND 1.5 OUNCES FROM ALL BRANDS.

18 (2) THE LIMITS ON CONSUMPTION SPECIFIED IN PARAGRAPH (1)
19 OF THIS SUBSECTION APPLY TO ONE INDIVIDUAL IN A SINGLE DAY.

20 (E) THE ANNUAL LICENSE FEE FOR THE BWLTL LICENSE IS \$100 IN
21 ADDITION TO THE FEE FOR ANY OTHER ALCOHOLIC BEVERAGES LICENSE HELD
22 BY THE LICENSE HOLDER.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 July 1, 2013.
