A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Montgomery County –**
3 **Our House Youth Home**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to provide that certain grants for the Our House Youth Home may not
6 terminate before a certain date; and generally relating to the Maryland
7 Consolidated Capital Bond Loan of 2006.

8 BY repealing and reenacting, with amendments,
9 Chapter 46 of the Acts of the General Assembly of 2006, as amended by Chapter
10 219 of the Acts of the General Assembly of 2008, Chapter 707 of the Acts
11 of the General Assembly of 2009, and Chapter 372 of the Acts of the
12 General Assembly of 2010
13 Section 1(3) Item ZA01(CP) and Item ZA02(AZ)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Chapter 46 of the Acts of 2006, as amended by Chapter 219 of the Acts of 2008,**
17 **Chapter 707 of the Acts of 2009, and Chapter 372 of the Acts of 2010**

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That:
