## A BILL ENTITLED

#### 1 AN ACT concerning

#### 2 Electrical Inspectors and Plumbing Inspectors – Master License Required

3 FOR the purpose of requiring a county or local government to employ as electrical 4 inspectors only individuals who hold, or have previously held within a certain  $\mathbf{5}$ period of time under certain circumstances, a State license or local license, as 6 applicable, to provide electrical services as a master electrician or who are 7 certified by certain entities; requiring a county or local government to employ as 8 plumbing inspectors only individuals who hold a master plumber license issued 9 by certain entities; providing certain exceptions to certain requirements of this Act: providing for the scope of certain provisions of this Act; providing for the 10 application of this Act; providing for a delayed effective date; and generally 11 12relating to licensing requirements for electrical inspectors and plumbing 13 inspectors.

AND BE IT FURTHER ENACTED, That this Act shall take effect 23January 1, 2014.
