A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2009 – Baltimore City – Roland**
3 **Park Fire Station Rehabilitation**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2009
5 to alter the purpose of a certain grant for the Roland Park Fire Station
6 Rehabilitation project; extending the deadline for a certain grantee to present
7 evidence of a matching fund and for certain funds to be expended or
8 encumbered; and generally relating to amending the Maryland Consolidated
9 Capital Bond Loan of 2009.

10 BY repealing and reenacting, with amendments,
11 Chapter 485 of the Acts of the General Assembly of 2009, as amended by
12 Chapter 396 of the Acts of the General Assembly of 2011
13 Section 1(3) Item ZA03(U)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That:

20 (3) ZA03 LOCAL SENATE INITIATIVES

21 (U) Roland Park Fire Station Rehabilitation. Provide a grant of
22 \$110,000, to the Mayor and City Council of the City of
23 Baltimore for the repair and renovation of the Roland Park
24 Fire Station, **INCLUDING THE REPAIR AND RENOVATION**

1 **OF HEAT PUMPS**, located in Baltimore City, subject to a
2 requirement that the grantee provide and expend a matching
3 fund of \$20,000. Notwithstanding Section 1(5) of this Act, the
4 matching fund may consist of in kind contributions or funds
5 expended prior to the effective date of this Act, and the
6 grantee has until [December 1, 2012] **DECEMBER 1, 2013**, to
7 present evidence that a matching fund will be provided.
8 Notwithstanding Section 1(7) of this Act, the proceeds of the
9 loan must be expended or encumbered by the Board of Public
10 Works for the purposes provided in this Act no later than 110,000
11 [December 1, 2012] **DECEMBER 1, 2013** (Baltimore City)

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
June 1, 2013.
