A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Ethics – Former Officials and Employees**

3 FOR the purpose of authorizing the ethics provisions enacted by Frederick County to
4 allow certain former officials or employees of the county to engage in certain
5 representation or assistance that related in a certain way to the officials' or
6 employees' former government activities after certain time periods; and
7 generally relating to the ethics requirements for Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – State Government**

21 15–504.

22 (d) (1) Except for a former member of the General Assembly, who shall be
23 subject to the restrictions provided under paragraph (2) of this subsection, a former
24 official or employee may not assist or represent a party, other than the State, in a
25 case, contract, or other specific matter for compensation if:

1 (i) the matter involves State government; and

2 (ii) the former official or employee participated significantly in
3 the matter as an official or employee.

4 (2) (i) Except as provided in subparagraph (ii) of this paragraph,
5 until the conclusion of the next regular session that begins after the member leaves
6 office, a former member of the General Assembly may not assist or represent another
7 party for compensation in a matter that is the subject of legislative action.

8 (ii) The limitation under subparagraph (i) of this paragraph on
9 representation by a former member of the General Assembly does not apply to the
10 former member's representation of a municipal corporation, county, or State
11 governmental entity.

13 (a) Except as provided in [subsection (b)] **SUBSECTIONS (B) AND (C)** of this
14 section, the conflict of interest provisions enacted by a county or municipal corporation
15 under § 15-803 of this subtitle shall be similar to the provisions of Subtitle 5 of this
16 title, but may be modified to the extent necessary to make the provisions relevant to
17 the prevention of conflicts of interest in that jurisdiction.

18 (b) **[The] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION,**
19 **THE** conflict of interest provisions for elected local officials enacted by a county or
20 municipal corporation under § 15-803 of this subtitle shall be equivalent to or exceed
21 the requirements of Subtitle 5 of this title, but may be modified to the extent
22 necessary to make the provisions relevant to the prevention of conflicts of interest in
23 that jurisdiction.

24 **(C) IN FREDERICK COUNTY, THE CONFLICT OF INTEREST PROVISIONS**
25 **THAT ARE BASED ON § 15-504(D) OF THIS TITLE MAY ALLOW A FORMER**
26 **OFFICIAL OR EMPLOYEE TO ASSIST OR REPRESENT A PARTY, FOR**
27 **COMPENSATION, IN A CASE, CONTRACT, OR OTHER SPECIFIC MATTER IN WHICH**
28 **THE INDIVIDUAL SIGNIFICANTLY PARTICIPATED AS AN OFFICIAL OR EMPLOYEE:**

29 **(1) FOR A FORMER ELECTED LOCAL OFFICIAL, AFTER 2 YEARS**
30 **HAVE ELAPSED FROM THE DATE THE FORMER ELECTED LOCAL OFFICIAL LEFT**
31 **THE ELECTED OFFICE;**

32 **(2) FOR A FORMER LOCAL OFFICIAL OR EMPLOYEE WHOSE**
33 **EMPLOYMENT OR SERVICE WAS TERMINATED BY THE COUNTY AND WHO WAS**
34 **NOT DISCHARGED FROM GOVERNMENT SERVICE AS A DISCIPLINARY MEASURE,**
35 **IMMEDIATELY ON LEAVING GOVERNMENT SERVICE OR EMPLOYMENT; AND**

1 **(3) FOR ALL OTHER FORMER OFFICIALS OR EMPLOYEES, AFTER 1**
2 **YEAR HAS ELAPSED FROM THE DATE THE FORMER OFFICIAL OR EMPLOYEE**
3 **LEFT GOVERNMENT OFFICE OR EMPLOYMENT.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2013.
