Except as provided in paragraphs (6), (7), (8), (9), (10), (11), 1 (i)  $\mathbf{2}$ (12), (13) and (14) of this subsection, no more than 12 winery special event permits are 3 issued to the Class 4 Maryland limited winery in any given calendar year; 4 (ii) The permit does not exceed 3 consecutive days; and Except as provided in paragraphs (6), (7), (8), (9), (10), (11),  $\mathbf{5}$ (iiii) 6 (12), (13), and (14) of this subsection, no more than three winery special event permits 7are issued in any calendar year to any given limited winery for use in the same 8 political subdivision. 9 In addition to the winery special event permits that may be (8)(i) 10 issued under paragraph (1)(i) and (iii) of this subsection, a Class 4 Maryland limited winery may be issued not more than [12] ONE winery special event [permits] PERMIT 11 12PER WEEK for use at farmers' markets in Montgomery County that are listed on the 13Farmers' Market Directory of the Maryland Department of Agriculture.
