CHAPTER

AN ACT concerning 1

$\mathbf{2}$ Vehicle Laws - Title and Registration - Transfer to Surviving Spouse

- 3 FOR the purpose of establishing that when the interest in a vehicle of one joint owner 4 passes by operation of law to another joint owner who is the surviving spouse, $\mathbf{5}$ the surviving spouse is not required to apply for a new certificate of title or 6 submit a certain certificate of title to the Motor Vehicle Administration until a 7 certain time; authorizing a surviving spouse to drive a certain vehicle and allow 8 the vehicle to be driven on a highway until a certain time without applying for a 9 certain registration if the interest in the vehicle passes to the surviving spouse 10 through joint ownership; prohibiting the Administration, on the death of a joint 11 owner of a vehicle, from charging a fee to another joint owner who is the 12 surviving spouse for the issuance of a new certificate of title for the vehicle; and 13generally relating to the title and registration of a vehicle transferred to a 14 surviving spouse.
