Election Law – Polling Places – Electioneering

FOR the purpose of requiring that electioneering be allowed on the premises of a public building that is used for a polling place up to a certain electioneering boundary; prohibiting a polling place from being located in a privately owned building unless the owner of the building agrees to allow electioneering on the premises up to a certain electioneering boundary; and generally relating to electioneering at polling places.

$\frac{3}{4}$	[(iii)] (IV) An election may be held in a building that is owned and occupied by an establishment that holds an alcoholic beverages license if:

7 8 9	2. the licensee agrees not to sell or dispense alcoholic beverages during the period beginning 2 hours before the polls open and ending 2 hours after the polls close; and
10 11	3. where applicable, all ballots are removed from the polling place by the local board immediately following the election.
