24	(b) (1) "Architectural services" means professional or creative work that:

3	(ii) requires architectural education, training, and experience.
4 5 6 7	(2) "Architectural services" includes consultation, research, investigation, evaluation, planning, architectural design and preparation of related documents, and coordination of services that structural, civil, mechanical, and electrical engineers and other consultants provide.
8 9 10	(3) "Architectural services" does not include construction inspection services [or], services provided in connection with an energy performance contract FOR STRUCTURAL, MECHANICAL, PLUMBING, OR ELECTRICAL ENGINEERING.
11	(i) (1) "Engineering services" means professional or creative work that:
12 13 14 15	(i) is performed in connection with any utility, structure, building, machine, equipment, or process, INCLUDING STRUCTURAL, MECHANICAL, PLUMBING, ELECTRICAL, GEOTECHNICAL, AND ENVIRONMENTAL ENGINEERING; and
16 17 18	(ii) requires engineering education, training, and experience in the application of special knowledge of the mathematical, physical, and engineering sciences.
19 20 21	(2) "Engineering services" includes consultation, investigation, evaluation, planning, design, and inspection of construction to interpret and ensure compliance with specifications and design within the scope of inspection services.
22 23	(3) "Engineering services" does not include services provided in connection with an energy performance contract.

25 26 27 28	(a) (1) Within 90 days after the end of the fiscal year, each unit shall report to the Governor's Office of Minority Affairs, the certification agency, and, subject to § 2–1246 of the State Government Article, the Joint Committee on Fair Practices and Personnel Oversight.

30 31 32 33	(i) state the total number and value of procurement contracts between the unit and certified minority business enterprises, by specific category of minority business enterprise, including whether the minority business enterprise participated as a prime contractor or as a subcontractor;

1 2 3	(ii) indicate the percentage that those procurement contracts represent, by specific category of minority business enterprise, of the total number and value of procurement contracts;
4 5 6	(iii) state the total number and the names of certified minority business enterprises that participated as prime contractors or as subcontractors on procurement contracts awarded by a unit;
7 8 9	(iv) for each minority business included in the report under item (iii) of this paragraph, list all procurement contracts awarded by a unit to the minority business enterprise, including a description of the contract; and
10 11 12	(v) contain other such information as required by the Governor's Office of Minority Affairs and the certification agency and approved by the Board.
