A BILL ENTITLED

1 AN ACT concerning

2 **Health Occupations – State Board of Social Work Examiners – Revisions**

3 FOR the purpose of renaming a certain license issued by the State Board of Social
4 Work Examiners; requiring the appointment of a certain licensee to the Board
5 within a certain number of months of a certain vacancy on the Board; altering
6 the number of signatures required for a certain list of nominees; authorizing
7 certain officers or directors to submit a certain list of nominees; exempting a
8 certain member of the Board from a certain requirement; requiring the Board to
9 elect certain officers for certain purposes; requiring the Board to determine the
10 manner of election of certain officers and the duties of certain officers;
11 exempting certain students from certain licensure requirements; requiring
12 certain applicants to complete a certain criminal history records check and
13 submit to a certain examination under certain circumstances; authorizing
14 certain applicants to meet certain licensure requirements by receiving a certain
15 degree; repealing a certain provisional graduate social worker license; altering
16 the number of hours of a certain type of supervision required to obtain a certain
17 license; altering certain education requirements required to obtain a certain
18 license; repealing the authority of the Board to waive a certain supervision
19 requirement under certain circumstances; requiring certain applicants for
20 licensure to submit certain fingerprints and certain fees to the Criminal Justice
21 Information System Central Repository of the Department of Public Safety and
22 Correctional Services; requiring the Central Repository to forward certain
23 criminal history record information to the Board and to certain applicants;
24 authorizing the Board to accept an alternate method of criminal history records
25 check under certain circumstances; providing that certain information obtained
26 from the Central Repository is confidential and may be used only for certain
27 purposes; authorizing certain subjects to contest certain contents of a certain
28 printed statement issued by the Central Repository; authorizing the Board to
29 require certain applicants to submit to certain examinations under certain
30 circumstances; providing that certain applicants are deemed to have consented
31 to submit to certain examinations and to have waived certain claims or

1 privileges relating to certain examination reports; providing that a certain
2 refusal to submit to certain examinations must be considered as certain
3 evidence of certain applicants' inability to practice social work in a certain
4 manner; repealing a certain obsolete provision; requiring the Board to maintain
5 a certain roster on its Web site of certain licensees; requiring the Board to
6 include certain information on certain licensee records; repealing a requirement
7 that the Board issue certain licenses; prohibiting certain licensees from
8 practicing social work, engaging in private practice, and diagnosing certain
9 disorders, except under certain circumstances; requiring the Board to send
10 certain notices to certain addresses that state certain information; requiring the
11 Board to maintain certain information regarding certain licensees; prohibiting
12 the Board from renewing certain licenses under certain circumstances;
13 exempting certain licensees from the maximum period of time during which a
14 licensee may be placed on a certain licensure status; requiring the Board to
15 provide certain licensees certain written notification under certain
16 circumstances; requiring the Board to reactivate certain licenses under certain
17 circumstances; requiring the Board to place certain licensees on nonrenewed
18 status for a certain period of time, subject to a certain exception, under certain
19 circumstances; altering certain grounds for discipline of certain licensees;
20 authorizing the Board to take certain actions if certain applicants or licensees
21 fail to comply with certain requirements pertaining to the maintenance,
22 disclosure, and destruction of medical records; altering the amount of a certain
23 fine that the Board may impose under certain circumstances; authorizing the
24 Board to issue certain subpoenas and administer certain oaths over certain
25 signatures; prohibiting the use of certain abbreviations under certain
26 circumstances; altering certain penalty provisions relating to violations of
27 certain provisions of law; making certain stylistic changes; altering certain
28 defined terms; defining certain terms; and generally relating to the State Board
29 of Social Work Examiners.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
4 MARYLAND, That the Laws of Maryland read as follows:

5 **Article – Health Occupations**

6 19–101.

7 (a) In this title the following words have the meanings indicated.

8 (b) “Board” means the State Board of Social Work Examiners.

9 (d) “License” means, unless the context requires otherwise, one of four types
10 of licenses issued by the Board authorizing an individual to practice:

11 (1) [Associate] **BACHELOR** social work;

12 (2) Graduate social work;

13 (3) Certified social work; or

14 (4) Certified social work–clinical.

15 (e) “Licensed [associate] **BACHELOR** social worker” means an individual
16 licensed by the Board to practice [associate] **BACHELOR** social work.

17 (i) “Practice [associate] **BACHELOR** social work” means to practice social
18 work:

19 (1) Under the supervision of a licensed certified social worker, licensed
20 certified social worker–clinical, or licensed graduate social worker who meets the
21 conditions specified in regulations; and

22 (2) Utilizing the education and training required under § 19–302(b) of
23 this title.

24 (j) “Practice certified social work” means to practice social work utilizing the
25 education, training, and experience required under § 19–302(d) [or (e)] of this title.

26 (m) (1) “Practice social work” means to apply the theories, knowledge,
27 procedures, methods, or ethics derived from a formal educational program in social
28 work to restore or enhance social functioning of individuals, couples, families, groups,
29 organizations, or communities through:

30 (i) Assessment;

- 1 [(ii) Formulating diagnostic impressions;]
- 2 [(iii)] **(II)** Planning;
- 3 [(iv)] **(III)** Intervention;
- 4 [(v)] **(IV)** Evaluation of intervention plans;
- 5 [(vi)] **(V)** Case management;
- 6 [(vii)] **(VI)** Information and referral;
- 7 [(viii)] **(VII)** Counseling that does not include diagnosis or
8 treatment of mental disorders;
- 9 [(ix)] **(VIII)** Advocacy;
- 10 [(x)] **(IX)** Consultation;
- 11 [(xi)] **(X)** Education;
- 12 [(xii)] **(XI)** Research;
- 13 [(xiii)] **(XII)** Community organization; or
- 14 [(xiv)] **(XIII)** Development, implementation, and administration of
15 policies, programs, and activities.
- 16 (2) For an individual licensed as a graduate social worker, “practice
17 social work” also includes:
- 18 (i) Supervision of other social workers if the graduate social
19 worker meets the requirements set out in regulations; [and]
- 20 **(II) FORMULATING A DIAGNOSIS, UNDER THE DIRECT**
21 **SUPERVISION OF A LICENSED CERTIFIED SOCIAL WORKER–CLINICAL;**
- 22 [(ii)] **(III)** Treatment of [psychosocial conditions]
23 **BIOPSYCHOSOCIAL CONDITIONS;** and
- 24 **(IV) TREATMENT OF** mental disorders and the provision of
25 psychotherapy under the direct supervision of a licensed certified social
26 worker–clinical.

1 (3) For an individual licensed as a certified social worker, “practice
2 social work” also includes:

3 (i) Supervision of other social workers; [and]

4 (II) **FORMULATING A DIAGNOSIS, UNDER THE DIRECT**
5 **SUPERVISION OF A LICENSED CERTIFIED SOCIAL WORKER–CLINICAL;**

6 [(ii)] (III) Treatment of [psychosocial conditions]
7 **BIOPSYCHOSOCIAL CONDITIONS;** and

8 (IV) **TREATMENT OF** mental disorders and the provision of
9 psychotherapy under the direct supervision of a licensed certified social
10 worker–clinical.

11 (4) For an individual licensed as a certified social worker–clinical,
12 “practice social work” also includes:

13 (i) Supervision of other social workers;

14 (ii) Evaluation, diagnosis, and treatment of [psychosocial]
15 **BIOPSYCHOSOCIAL** conditions, mental and emotional conditions and impairments,
16 and mental disorders as defined in § 10–101(f) of the Health – General Article; [and]

17 (III) **PETITIONING FOR EMERGENCY EVALUATION UNDER**
18 **TITLE 10, SUBTITLE 6 OF THE HEALTH – GENERAL ARTICLE; AND**

19 [(iii)] (IV) The provision of psychotherapy.

20 (n) “Psychotherapy” means [a method for] the **ASSESSMENT AND** treatment
21 of mental disorders and behavioral disturbances [in which a licensed health care
22 practitioner enters into a professional contract with the patient and, through a
23 therapeutic communication or interaction, attempts to:

24 (1) Alleviate emotional disturbances;

25 (2) Reverse or alter maladaptive patterns of behavior; or

26 (3) Encourage personality growth and development].

27 19–202.

28 (a) (3) If a licensed [social work associate] **BACHELOR SOCIAL WORKER,**
29 a licensed graduate social worker, a licensed certified social worker, a licensed
30 certified social worker–clinical, or a licensed social worker is not appointed to the

1 Board under paragraph (2)(i) of this subsection within [6] 3 months of a vacancy, a
2 licensee of any license level shall be appointed immediately if that licensee is qualified
3 to be a member of the Board under subsections (b) and (d) of this section.

4 (5) The Governor shall appoint all social work members of the Board
5 from a list of nominees containing names submitted by:

6 (i) Professional social work associations in the State;

7 (ii) Any person who provides a statement of nomination signed
8 by at least [25] 15 social workers licensed in the State; [or]

9 (iii) The secretaries of public agencies of the State where social
10 workers are employed; **OR**

11 (IV) **THE CORPORATE EXECUTIVE OFFICERS OR EXECUTIVE**
12 **DIRECTORS OF PRIVATE ORGANIZATIONS WHERE SOCIAL WORKERS ARE**
13 **EMPLOYED.**

14 (d) Except for the licensed **BACHELOR** social worker [associate] member and
15 the licensed graduate social worker member, each social worker member of the Board
16 shall have been licensed in the State for 5 years immediately preceding the
17 appointment and actively employed in the field of social work for at least 3 of the 5
18 years immediately preceding the appointment.

20 (a) (1) From among its members, the Board shall elect a [chairman]
21 **CHAIR, VICE CHAIR, and [a secretary] SECRETARY–TREASURER** every 2 years.

22 (2) The Board may elect other officers as necessary to fulfill the duties
23 and responsibilities of the Board.

24 (b) The Board shall determine:

25 (1) The manner of election of the [chairman, secretary,] **CHAIR,**
26 **VICE CHAIR, SECRETARY–TREASURER,** and other officers; and

27 (2) The duties of each officer.

28 19–301.

29 (a) Except as otherwise provided in this title, an individual shall be:

30 (1) Licensed by the Board before the individual may practice social
31 work in this State while representing oneself as a social worker; or

1 (2) Licensed as a certified social worker–clinical before the individual
2 may practice clinical social work in this State.

3 (b) This section does not apply to:

4 (1) An individual employed by any agency of the federal government
5 while performing the duties of that employment;

6 (2) An individual licensed as a social worker in another state while
7 responding to an emergency in this State; [or]

8 (3) An individual who:

9 (i) Is licensed to practice social work in any other state;

10 (ii) Has an application for a license pending before the Board;
11 and

12 (iii) Meets requirements established by the Board in regulations;
13 **OR**

14 **(4) A STUDENT WHILE PURSUING A SUPERVISED COURSE OF**
15 **STUDY IN A SOCIAL WORK PROGRAM THAT IS ACCREDITED OR IS A CANDIDATE**
16 **FOR ACCREDITATION BY THE COUNCIL ON SOCIAL WORK EDUCATION.**

17 (c) An individual may not practice social work without a license under
18 subsection (b)(3) of this section for more than 6 months.

19 19–302.

20 (a) To obtain a license, an applicant shall demonstrate to the satisfaction of
21 the Board that the applicant:

22 (1) Has submitted a complete written application in the form
23 prescribed by the Board;

24 (2) Is at least 18 years old;

25 (3) Is of good moral character;

26 (4) Except as otherwise provided in this title, has successfully passed
27 an examination or examinations prescribed by the Board pertinent to the license
28 sought; [and]

1 2. Until the program has attained accredited status from
2 the Council on Social Work Education or an equivalent organization approved by the
3 Council on Social Work Education.

4 (iii) Provisional licensees whose degree programs become
5 accredited during the license period shall be permitted to apply for a license as a
6 graduate social worker upon accreditation being granted to the program.]

7 (d) Except as provided in § 19–302.1 of this subtitle, to obtain a certified
8 social worker license, an applicant shall:

9 (1) Meet the requirements of subsection (a) of this section;

10 (2) Have received a master’s degree from a program accredited by the
11 Council on Social Work Education or an equivalent organization approved by the
12 Council on Social Work Education; and

13 (3) Except as provided in subsection (g) of this section, provide in a
14 form prescribed by the Board, documentation of having completed 2 years as a licensee
15 with supervised experience of at least 3,000 hours after receiving the master’s degree
16 with a minimum of [144] **100** hours of periodic face-to-face supervision in the practice
17 of social work under the terms and conditions that the Board determines by
18 regulation.

19 (e) Except as provided in § 19–302.1 of this subtitle, to obtain a certified
20 social worker-clinical license, an applicant shall:

21 (1) Meet the requirements of subsection (a) of this section;

22 (2) Have received a master’s degree in social work and documentation
23 of **COMPLETION OF 12 ACADEMIC CREDITS IN** clinical course work from a
24 **MASTER’S DEGREE** program accredited by the Council on Social Work Education or
25 an equivalent organization approved by the Council on Social Work Education; and

26 (3) Provide in a form prescribed by the Board, documentation of
27 having completed 2 years as a licensee with supervised experience of at least 3,000
28 hours, **OF WHICH 1,500 HOURS ARE IN FACE-TO-FACE CLIENT CONTACT**, after
29 receiving the master’s degree with a minimum of 144 hours of periodic face-to-face
30 supervision in the assessment, formulation of a diagnostic impression, and treatment
31 of mental disorders and other conditions and the provision of psychotherapy under the
32 terms and conditions that the Board determines by regulation.

33 [(f) If the supervision required for a certified social worker license under
34 subsection (d)(3) of this section was not available to the applicant while the applicant
35 was obtaining the required 2 years of experience, the Board may waive the supervision
36 requirement on the request of the applicant.

1 (g) If an applicant who is licensed or registered to practice social work in
2 another state has obtained 2 years of supervised experience under circumstances that
3 are otherwise equivalent to those required under subsection (d) of this section, the
4 Board may waive the supervision requirement.]

5 **19-302.2.**

6 (A) IN THIS SECTION, "CENTRAL REPOSITORY" MEANS THE CRIMINAL
7 JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT
8 OF PUBLIC SAFETY AND CORRECTIONAL SERVICES.

9 (B) AS PART OF AN APPLICATION TO THE CENTRAL REPOSITORY FOR A
10 STATE AND NATIONAL CRIMINAL HISTORY RECORDS CHECK, AN APPLICANT
11 SHALL SUBMIT TO THE CENTRAL REPOSITORY:

12 (1) TWO COMPLETE SETS OF LEGIBLE FINGERPRINTS TAKEN ON
13 FORMS APPROVED BY THE DIRECTOR OF THE CENTRAL REPOSITORY AND THE
14 DIRECTOR OF THE FEDERAL BUREAU OF INVESTIGATION;

15 (2) THE FEE AUTHORIZED UNDER § 10-221(B)(7) OF THE
16 CRIMINAL PROCEDURE ARTICLE FOR ACCESS TO STATE CRIMINAL HISTORY
17 RECORDS; AND

18 (3) THE PROCESSING FEE REQUIRED BY THE FEDERAL BUREAU
19 OF INVESTIGATION FOR A NATIONAL CRIMINAL HISTORY RECORDS CHECK.

20 (C) IN ACCORDANCE WITH §§ 10-201 THROUGH 10-228 OF THE
21 CRIMINAL PROCEDURE ARTICLE, THE CENTRAL REPOSITORY SHALL FORWARD
22 TO THE BOARD AND TO THE APPLICANT THE CRIMINAL HISTORY RECORD
23 INFORMATION OF THE APPLICANT.

24 (D) IF AN APPLICANT HAS MADE TWO OR MORE UNSUCCESSFUL
25 ATTEMPTS AT SECURING LEGIBLE FINGERPRINTS, THE BOARD MAY ACCEPT AN
26 ALTERNATE METHOD OF CRIMINAL HISTORY RECORDS CHECK AS PERMITTED
27 BY THE DIRECTOR OF THE CENTRAL REPOSITORY AND THE DIRECTOR OF THE
28 FEDERAL BUREAU OF INVESTIGATION.

29 (E) INFORMATION OBTAINED FROM THE CENTRAL REPOSITORY UNDER
30 THIS SECTION:

31 (1) IS CONFIDENTIAL AND MAY NOT BE REDISSEMINATED; AND

1 **(2) MAY BE USED ONLY FOR THE LICENSING PURPOSE**
2 **AUTHORIZED BY THIS TITLE.**

3 **(F) THE SUBJECT OF A CRIMINAL HISTORY RECORDS CHECK UNDER**
4 **THIS SECTION MAY CONTEST THE CONTENTS OF THE PRINTED STATEMENT**
5 **ISSUED BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10-223 OF THE**
6 **CRIMINAL PROCEDURE ARTICLE.**

7 **19-302.3.**

8 **(A) THE BOARD MAY REQUIRE AN APPLICANT TO SUBMIT TO A MENTAL**
9 **OR PHYSICAL EXAMINATION BY A HEALTH CARE PRACTITIONER DESIGNATED BY**
10 **THE BOARD IF THE BOARD:**

11 **(1) HAS REASON TO BELIEVE THAT THE APPLICANT MAY CAUSE**
12 **HARM TO THE APPLICANT OR TO ANOTHER PERSON;**

13 **(2) MAKES A WRITTEN REQUEST FOR THE APPLICANT TO SUBMIT**
14 **TO THE EXAMINATION;**

15 **(3) PROVIDES THE APPLICANT WITH A LIST OF THREE HEALTH**
16 **CARE PRACTITIONERS FROM WHICH THE APPLICANT MAY CHOOSE A HEALTH**
17 **CARE PRACTITIONER TO CONDUCT THE EXAMINATION; AND**

18 **(4) PAYS THE COST OF THE EXAMINATION.**

19 **(B) AN APPLICANT REQUIRED TO SUBMIT TO AN EXAMINATION UNDER**
20 **SUBSECTION (A) OF THIS SECTION SHALL BE DEEMED TO HAVE:**

21 **(1) CONSENTED TO SUBMIT TO THE EXAMINATION; AND**

22 **(2) WAIVED ANY CLAIM OR PRIVILEGE AS TO THE EXAMINATION**
23 **REPORT.**

24 **(C) THE REFUSAL OF AN APPLICANT TO SUBMIT TO THE EXAMINATION**
25 **REQUIRED UNDER SUBSECTION (A) OF THIS SECTION SHALL BE PRIMA FACIE**
26 **EVIDENCE OF THE APPLICANT'S INABILITY TO PRACTICE SOCIAL WORK**
27 **COMPETENTLY, UNLESS THE BOARD FINDS THAT THE REFUSAL WAS BEYOND**
28 **THE CONTROL OF THE APPLICANT.**

29 **19-304.**

30 **(a) An approved applicant is entitled to be examined for licensure as**
31 **provided in this section.**

1 (b) The Board shall ensure that a Board-approved examination for each
2 category of license is made available for an applicant to take at least twice a year, at
3 the times and places that the Board determines.

4 (c) The Board shall notify each approved applicant of the procedures for
5 taking the examination.

6 (d) (1) The Board shall approve the subjects, scope, form, and passing
7 score for each type of examination given under this subtitle.

8 (2) The examinations given under this subtitle shall strive to be free of
9 cultural bias.

10 (e) (1) The Board, by regulation, may limit:

11 (i) The number of times an applicant may be reexamined after
12 failing an examination required under this subtitle; and

13 (ii) The interval between reexaminations.

14 (2) If an applicant is permitted to be reexamined under paragraph (1)
15 of this subsection, the applicant shall pay a fee to the examining body approved by the
16 Board.

17 [(f) Notwithstanding the provisions of § 19-302 of this subtitle, an applicant
18 for a certified social worker license or a certified social worker-clinical license who was
19 enrolled in a doctoral program on October 1, 1992 and has remained continuously
20 enrolled in a doctoral program and who otherwise qualifies for the applicable license is
21 entitled to be examined for that license as provided in this section.]

22 [(g) (F) The examination shall be prepared to measure the competence of
23 the applicant to engage in the pertinent practice of social work.

24 [(h) (G) In the preparation, administration, and grading of an examination,
25 the Board may employ, cooperate, or contract with an organization or consultant.

26 19-306.

27 (a) The Board shall [issue a license to any applicant who meets] **MAINTAIN**
28 **ON ITS WEB SITE A ROSTER OF ALL LICENSEES WHO MEET** the requirements of
29 this title.

30 (b) The Board shall include on each **ELECTRONIC** license [that the Board
31 issues] **RECORD:**

- 1 (1) The kind of license;
- 2 (2) The full name of the licensee;
- 3 (3) A [serial] **LICENSE** number;
- 4 (4) The [signatures of the chairman and the secretary of the Board]
- 5 **LICENSE STATUS;**
- 6 (5) The [seal of the Board] **EXPIRATION DATE**; and
- 7 (6) The original date of issuance.

8 [(c) The Board shall issue a license to replace a lost, destroyed, or mutilated
9 license if the licensee pays the license replacement fee set by the Board and
10 demonstrates to the satisfaction of the Board that the license was lost, destroyed, or
11 mutilated.]

- 13 (c) (1) A licensed [associate] **BACHELOR** social worker may not:
- 14 (i) Practice social work without the supervision of a licensed
15 certified social worker, licensed certified social worker–clinical, or licensed graduate
16 social worker who meets the requirements specified in the regulations;
- 17 (ii) Make a clinical diagnosis of a mental or emotional disorder;
- 18 **[or]**
- 19 (iii) Provide psychotherapy; **OR**
- 20 **(IV) ENGAGE IN PRIVATE PRACTICE.**
- 21 (2) A licensed graduate social worker may not:
- 22 (i) Practice graduate social work without the supervision of a
23 licensed certified social worker, licensed certified social worker–clinical, or licensed
24 graduate social worker who meets the requirements specified in the regulations;
- 25 (ii) Treat mental or emotional disorders or provide
26 psychotherapy without the direct supervision of a licensed certified social
27 worker–clinical; **[or]**
- 28 (iii) Diagnose a mental disorder **WITHOUT THE DIRECT**
29 **SUPERVISION OF A LICENSED CERTIFIED SOCIAL WORKER–CLINICAL; OR**

1 **(IV) ENGAGE IN PRIVATE PRACTICE WITHOUT THE DIRECT**
2 **SUPERVISION OF A LICENSED CERTIFIED SOCIAL WORKER–CLINICAL.**

3 (3) A licensed certified social worker may not:

4 (i) Treat mental or emotional disorders or provide
5 psychotherapy without the direct supervision of a licensed certified social
6 worker–clinical; or

7 (ii) Diagnose a mental disorder **WITHOUT THE DIRECT**
8 **SUPERVISION OF A LICENSED CERTIFIED SOCIAL WORKER–CLINICAL.**

9 19–308.

10 (b) At least 1 month before the license expires, the Board shall send to the
11 licensee, [by first–class mail to] **AT** the last known **ELECTRONIC OR PHYSICAL**
12 address of the licensee, a renewal notice that states:

13 (1) The date on which the current license expires;

14 (2) The date by which the renewal application must be received by the
15 Board for the renewal to be issued and mailed before the license expires; and

16 (3) The amount of the renewal fee.

17 (e) (1) The Board shall renew the license of and issue a renewal certificate
18 to each licensee who meets the requirements of this section.

19 (2) The Board shall [include the term of the renewal on each renewal
20 certificate that the Board issues] **MAINTAIN THE SAME INFORMATION ON EACH**
21 **LICENSEE.**
