2 **Health – Overdose Response Program – Establishment**

3 FOR the purpose of providing for an Overdose Response Program overseen by the
4 Department of Health and Mental Hygiene; stating the purpose of the Program;
5 ~~authorizing~~ requiring the Department to adopt certain regulations and
6 authorizing the Department to take certain other action regarding the Program;
7 specifying the requirements an individual must meet to qualify for a certain
8 certificate; requiring that a certain educational training program be conducted
9 by a physician or nurse practitioner or certain other individuals and include
10 certain training; requiring an applicant for a certificate to submit a certain
11 application; requiring a certain public or private entity to issue a certificate to
12 an applicant under certain circumstances; requiring that a certificate contain
13 certain information; providing that a replacement certificate may be issued
14 under certain circumstances; providing for the term and renewal of a certain
15 certificate; authorizing an individual who is certified to receive from a certain
16 individual a prescription for naloxone and certain supplies, possess prescribed
17 naloxone and certain paraphernalia, and administer naloxone, under certain
18 circumstances, to certain individuals; authorizing a physician or nurse
19 practitioner to prescribe and dispense naloxone to a certificate holder;

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article – Health – General

SUBTITLE 31. OVERDOSE RESPONSE PROGRAM.

(C) “PRIVATE OR PUBLIC ENTITY” MEANS A HEALTH CARE PROVIDER, LOCAL HEALTH DEPARTMENT, COMMUNITY–BASED ORGANIZATION, SUBSTANCE ABUSE TREATMENT ORGANIZATION, OR OTHER PERSON THAT ADDRESSES MEDICAL OR SOCIAL ISSUES RELATED TO DRUG ADDICTION.

(D) “PROGRAM” MEANS AN OVERDOSE RESPONSE PROGRAM.
