A BILL ENTITLED

1 AN ACT concerning

2 **Corporate Income Tax – Rate Reduction and Reform**

3 FOR the purpose of altering the State income tax rate on the Maryland taxable income of
4 corporations; providing for the application of this Act; and generally relating to the
5 income tax on corporations.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – Tax – General**

14 10–105.

15 (b) The State income tax rate for a corporation is [8.25%] 4% of Maryland
16 taxable income.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 July 1, 2013, and shall be applicable to all taxable years beginning after December 31,
19 2013.
