A BILL ENTITLED

1 AN ACT concerning

2 **Washington Metropolitan Area Transit District – Establishment of Sales**
3 **Outlets in Prince George's County**

4 **MC/PG 117–13**

5 FOR the purpose of requiring the Washington Suburban Transit Commission to take
6 any action necessary to enter the Washington Suburban Transit District into a
7 contract or agreement with the Washington Metropolitan Transit Authority to
8 establish at least three sales outlets in Prince George's County at which senior
9 citizens may purchase discounted fare cards; requiring sales outlets established
10 in accordance with this Act to be located at certain locations in Prince George's
11 County; and generally relating to the Washington Suburban Transit District
12 and sales outlets in Prince George's County.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
24 MARYLAND, That the Laws of Maryland read as follows:

2 **(B) (1) THE COMMISSION SHALL TAKE ANY ACTION NECESSARY TO**
3 **ENTER THE DISTRICT INTO A CONTRACT OR AGREEMENT WITH THE AUTHORITY**
4 **TO ESTABLISH AT LEAST THREE SALES OUTLETS IN PRINCE GEORGE'S COUNTY**
5 **AT WHICH SENIOR CITIZENS MAY PURCHASE DISCOUNTED FARE CARDS**
6 **OFFERED FOR SALE BY THE AUTHORITY.**

7 **(2) THE SALES OUTLETS ESTABLISHED IN ACCORDANCE WITH**
8 **THIS SUBSECTION SHALL BE LOCATED AS FOLLOWS:**
