CHAPTER _____

1 AN ACT concerning

2 **Crimes – Threat of Mass Violence**

3 FOR the purpose of prohibiting a person from threatening to commit, or causing to be
4 committed, a certain crime of violence that would place others at substantial
5 risk of death or serious physical injury if there are certain probable
6 consequences of the threat; establishing that this Act applies to a threat made
7 by oral or written communication or electronic mail; establishing that a person
8 who violates this Act is guilty of the ~~felony~~ misdemeanor of making a threat of
9 mass violence; establishing a penalty for a violation of this Act; requiring a
10 court to order a person convicted under this Act to reimburse certain persons;
11 providing for the venue for a prosecution under this Act; defining certain terms;
12 and generally relating to the ~~felony~~ misdemeanor of making a threat of mass
13 violence.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Criminal Law**

3 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**
4 **MEANINGS INDICATED.**

5 **(2) “DWELLING” HAS THE MEANING STATED IN § 6-201 OF THIS**
6 **ARTICLE.**

7 **(3) “PUBLIC PLACE” HAS THE MEANING STATED IN § 10-201 OF**
8 **THIS ARTICLE.**

9 **(4) “STOREHOUSE” HAS THE MEANING STATED IN § 6-201 OF**
10 **THIS ARTICLE.**

11 **(B) THIS SECTION APPLIES TO A THREAT MADE BY ORAL OR WRITTEN**
12 **COMMUNICATION OR ELECTRONIC MAIL, AS DEFINED IN § 3-805(A) OF THIS**
13 **TITLE.**

14 **(C) A PERSON MAY NOT KNOWINGLY THREATEN TO COMMIT, OR CAUSE**
15 **TO BE COMMITTED, A CRIME OF VIOLENCE, AS DEFINED IN § 14-101 OF THIS**
16 **ARTICLE, THAT WOULD PLACE OTHERS AT SUBSTANTIAL RISK OF DEATH OR**
17 **SERIOUS PHYSICAL INJURY, AS DEFINED IN § 3-201 OF THIS TITLE, IF THE**
18 **NATURAL AND PROBABLE CONSEQUENCE OF THE THREAT, REGARDLESS OF**
19 **WHETHER THE CONSEQUENCE OCCURS, IS THAT FIVE OR MORE PEOPLE ARE:**

20 **(1) PLACED IN REASONABLE FEAR THAT THE CRIME WILL BE**
21 **COMMITTED;**

22 **(2) EVACUATED FROM A DWELLING, STOREHOUSE, OR PUBLIC**
23 **PLACE;**

24 **(3) MOVED TO A DESIGNATED AREA WITHIN A DWELLING,**
25 **STOREHOUSE, OR PUBLIC PLACE; OR**

26 **(4) REQUIRED TO REMAIN IN A DESIGNATED SAFE AREA WITHIN A**
27 **DWELLING, STOREHOUSE, OR PUBLIC PLACE.**

28 **(D) (1) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF THE**
29 **~~FELONY~~ MISDEMEANOR OF MAKING A THREAT OF MASS VIOLENCE AND ON**
30 **CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 10 YEARS OR A**
31 **FINE NOT EXCEEDING \$10,000 OR BOTH.**

1 **(2) IN ADDITION TO THE PENALTIES PROVIDED IN PARAGRAPH**
2 **(1) OF THIS SUBSECTION, A COURT SHALL ORDER A PERSON CONVICTED UNDER**
3 **THIS SECTION TO REIMBURSE THE APPROPRIATE UNIT OF FEDERAL, STATE, OR**
4 **LOCAL GOVERNMENT OR OTHER PERSON FOR EXPENSES AND LOSSES**
5 **INCURRED IN RESPONDING TO THE UNLAWFUL THREAT UNLESS THE COURT**
6 **STATES ON THE RECORD THE REASONS WHY REIMBURSEMENT WOULD BE**
7 **INAPPROPRIATE.**

8 **(E) A PERSON WHO VIOLATES THIS SECTION MAY BE INDICTED,**
9 **PROSECUTED, TRIED, AND CONVICTED IN ANY COUNTY WHERE:**

10 **(1) THE THREAT WAS RECEIVED;**

11 **(2) THE THREAT WAS MADE; OR**

12 **(3) THE CONSEQUENCES OF THE THREAT OCCURRED.**

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2013.
