A BILL ENTITLED

1 AN ACT concerning

2 **City of Annapolis – Alcoholic Beverages – Residency Requirement**

3 FOR the purpose of specifying that an applicant for an alcoholic beverages license in
4 the City of Annapolis may meet the residency requirement by residing
5 anywhere in Anne Arundel County for a certain number of years before filing an
6 application for the license; making stylistic changes; and generally relating to
7 alcoholic beverages licenses in the City of Annapolis.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article 2B – Alcoholic Beverages**

16 10–103.

17 (b) Except as otherwise provided in this subtitle, every new application for a
18 license shall be made to the Board of License Commissioners on forms prescribed by
19 the Comptroller and sworn to by the applicant. Every application for a license shall
20 contain the following:

21 (4) (i) Except as provided in subparagraphs [(ii) and (iv)] **(III) AND**
22 **(V)** of this paragraph, a statement that the applicant has been for two years next
23 preceding the filing of the application a resident of the county or of the City of
24 Baltimore in which the applicant proposes to operate under the license applied for.

1 **(II)** The Board of License Commissioners of Prince George's
2 County shall apply the residency requirements as specified in § 9–101 of this article[;].

3 [(ii)] **(III)** In Dorchester County the residency requirement is 1
4 year[;].

5 [(iii)] **(IV)** In Carroll County, in addition to the applicant's
6 residential statement required under this section, the license shall remain valid only
7 for as long as the resident applicant remains a resident of the county[;].

8 [(iv)] **(V)** In Baltimore County, a statement that the applicant
9 has been for 2 years next preceding the filing of the application a resident of the State
10 **IS REQUIRED.**

11 **(VI) AN APPLICANT FOR A LICENSE ISSUED IN THE CITY OF**
12 **ANNAPOLIS MAY MEET THE RESIDENCY REQUIREMENT BY RESIDING ANYWHERE**
13 **IN ANNE ARUNDEL COUNTY.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 July 1, 2013.
