2 **Prince George's County Sheriff – ~~Salary Increase~~ Compensation and Salaries**

4 FOR the purpose of ~~increasing the annual salary of the Sheriff of Prince George's~~  
5 ~~County to a certain amount over a certain time period~~ repealing the method of  
6 determining the annual salary of the Sheriff of Prince George's County  
7 beginning with a certain calendar year; providing that beginning with a certain  
8 calendar year, the annual salary of the Sheriff shall equal the salary of a circuit  
9 court judge; providing that this Act does not apply to the salary or compensation  
10 of the incumbent Sheriff during a certain term of office; and generally relating  
11 to the salary of the Sheriff of Prince George's County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
18 MARYLAND, That the Laws of Maryland read as follows:

7 4. \$127,629 for calendar year 2009; and

8 5. \$132,734 for calendar year 2010]

19 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §  
 20 35 of the Maryland Constitution, this Act may not be construed to extend or apply to  
 21 the salary or compensation of the Sheriff of Prince George's County during a term of  
 22 office beginning before the effective date of this Act, but the provisions of this Act  
 23 concerning the salary or compensation of the Sheriff of Prince George's County shall  
 24 take effect at the beginning of the next following term of office.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 26 October 1, 2013.
