## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2003 – Prince George’s County**  
3 **– Bethel Recreation Center**

4 FOR the purpose of amending the Community Based Regional Initiatives Loan of 2004  
5 to alter the purpose of a certain grant; providing that a certain grant may not  
6 terminate before a certain date; and generally relating to amending the  
7 Maryland Consolidated Capital Bond Loan of 2003.

8 BY repealing and reenacting, with amendments,  
9 Chapter 204 of the Acts of the General Assembly of 2003, as amended by  
10 Chapter 707 of the Acts of the General Assembly of 2009  
11 Section 12(3)(I)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Chapter 204 of the Acts of 2003, as amended by Chapter 707 of the Acts of**  
15 **2009**

16 SECTION 12. AND BE IT FURTHER ENACTED, That:

17 (3)

18 (I) Bethel Senior Facilities. Provide a grant equal to the lesser of  
19 (i) \$250,000 or (ii) the amount of the matching fund provided,  
20 to the Board of Trustees of Union Bethel A.M.E. Church for  
21 the planning, design, construction, and capital equipping of  
22 the Bethel Senior Facilities, **INCLUDING INSTALLATION OF**  
23 **A SEWER PIPELINE**, located in Brandywine. Notwithstanding  
24 the provisions of Section 12(5) of this Act, the matching fund

1           may include real property, in kind contributions, or funds  
 2           expended prior to the effective date of this Act and the grantee  
 3           has until June 1, 2011, to present evidence that a matching  
 4           fund will be provided. **NOTWITHSTANDING ANY OTHER**  
 5           **PROVISION OF LAW, THIS GRANT MAY NOT TERMINATE**  
 6           **BEFORE JUNE 1, 2014** (Prince George’s County) ..... 250,000

7           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 8           June 1, 2013.
