## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2012 – Prince George’s County**  
3 **– Labor of Love Learning Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2012  
5 to authorize a required matching fund for a certain grant for the Labor of Love  
6 Learning Center to consist of funds expended prior to a certain date; and  
7 generally relating to amending the Maryland Consolidated Capital Bond Loan  
8 of 2012.

9 BY repealing and reenacting, with amendments,  
10 Chapter 444 of the Acts of the General Assembly of 2012  
11 Section 1(3) Item ZA02(BI) and Item ZA03(AU)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:
