A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Prince George’s County**
3 **– Walker Mill Daycare and Training Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010
5 to extend the deadline for the Board of Directors of Walker Mill Development,
6 Inc. to present evidence that a certain matching fund will be provided; providing
7 that a certain grant may not terminate before a certain date; altering the
8 purpose of a certain grant; and generally relating to amending the Maryland
9 Consolidated Capital Bond Loan of 2010.

11 Chapter 483 of the Acts of the General Assembly of 2010, as amended by
12 Chapter 639 of the Acts of the General Assembly of 2012
13 Section 1(3) Item ZA03(BI)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That:

20 (3) ZA03 LOCAL HOUSE OF DELEGATES INITIATIVES

21 (BI) Walker Mill Daycare and Training Center. Provide a grant
22 equal to the lesser of (i) \$100,000 or (ii) the amount of the
23 matching fund provided, to the Board of Directors of Walker

1 Mill Development, Inc. for the **ACQUISITION**, construction,
 2 and capital equipping of the Walker Mill Daycare and
 3 Training Center, located in Capitol Heights. Notwithstanding
 4 Section 1(5) of this Act, the matching fund may consist of in
 5 kind contributions and the grantee has until June 1, **[2013,]**
 6 **2014**, to present evidence that a matching fund will be
 7 provided. Notwithstanding Section 1(7) of this Act, this grant
 8 may not terminate before June 1, **[2013] 2014** (Prince
 9 George’s County) 100,000

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 11 June 1, 2013.
