2 **Division of Labor and Industry and Associated Boards and Councils – Sunset**
3 **Extension and Program Evaluation**

4 FOR the purpose of continuing the State Amusement Ride Safety Advisory Board, the
5 Occupational Safety and Health Advisory Board, the Apprenticeship and
6 Training Council, and the Board of Boiler Rules in accordance with the
7 provisions of the Maryland Program Evaluation Act (Sunset Law) by extending
8 to a certain date the termination provisions relating to the statutory and
9 regulatory authority of the boards and council; altering certain termination
10 provisions to apply only to certain boards and a certain council; repealing the
11 termination provision for the Division of Labor and Industry; repealing a
12 certain termination provision that applies to the regulation of the employment
13 of minors and wages and hours; requiring that an evaluation be made of the
14 Division of Labor and Industry on or before a certain date; repealing the

 6 MARYLAND, That the Laws of Maryland read as follows:

9 (b) (1) The Board shall meet at least twice a year at a location and in an
 10 office provided by the State.

11 (2) The Board may hold special meetings as provided in its
 12 regulations.

26 (b) “Client” means an individual who seeks employment through an
 27 employment agency.

28 (c) [“Commissioner” means the Commissioner of Labor and Industry.

29 (d) (1) “Employment agency” means a person who, for a fee:

- 1 (i) obtains, offers to obtain, or attempts to obtain:
- 2 1. an employee for a person who seeks an employee; or
- 3 2. employment for a client;
- 4 (ii) provides to a client information to enable the client to obtain
- 5 employment;
- 6 (iii) obtains, offers to obtain, or attempts to obtain employment
- 7 or an engagement in connection with an entertainment, exhibition, or performance,
- 8 including:
- 9 1. a ballet;
- 10 2. a circus;
- 11 3. a concert;
- 12 4. the legitimate theater;
- 13 5. modeling;
- 14 6. a motion picture;
- 15 7. an opera;
- 16 8. a phonograph recording;
- 17 9. the radio;
- 18 10. a transcription;
- 19 11. television;
- 20 12. the variety field; or
- 21 13. vaudeville; or
- 22 (iv) 1. obtains, offers to obtain, or attempts to obtain an
- 23 alien labor certification or immigrant visa for an individual; and
- 24 2. participates directly or indirectly in the recruitment
- 25 or supply of an individual who resides outside of the continental United States for
- 26 employment in the continental United States.
- 27 (2) “Employment agency” does not include a person who merely:

- 1 (i) conducts a business that directly employs individuals to
2 provide part-time or temporary services to another person;
- 3 (ii) as a lawyer, directly obtains an immigrant visa for an
4 individual;
- 5 (iii) conducts a business that:
- 6 1. receives a fee that is paid wholly by an employer;
- 7 2. does not collect money from an individual seeking
8 employment; and
- 9 3. does not require an individual seeking employment to
10 make a contract; or
- 11 (iv) operates a nursing referral service agency that is licensed
12 under Title 19, Subtitle 4B of the Health – General Article.

25 (3) be signed by an individual authorized to do so by the employment
26 agency as principal and by a surety company authorized to do business in the State as
27 surety; and

1 (4) be conditioned that the employment agency will comply with this
2 title and will pay to any person all damages caused by deceit, fraud,
3 misrepresentation, or misstatement of the employment agency or an agent or
4 employee of the employment agency.

5 (c) To ensure that each employment agency submits the penal bond in
6 accordance with this section, the Commissioner may initiate an investigation or
7 investigate a complaint that an employment agency has failed to submit a penal bond.

8 (d) If, after investigation, the Commissioner finds that an employment
9 agency has failed to submit a penal bond as required by this section, the
10 Commissioner shall give written notice that directs the employment agency, within 15
11 days after receipt of the notice:

12 (1) to submit the required bond; or

13 (2) to show written cause why the employment agency is not required
14 to comply with this section.

15 (e) (1) If the employment agency complies with the requirement to submit
16 a bond or otherwise submits a timely response, the Commissioner may:

17 (i) terminate proceedings against the employment agency; or

18 (ii) schedule a hearing and, by certified mail, give the
19 employment agency written notice of the date, place, and time of the hearing.

20 (2) If the employment agency fails to comply with a lawful order of the
21 Commissioner or fails to submit a timely response, the Commissioner may impose a
22 civil penalty of not less than \$500 and not more than \$1,000 for each failure to comply
23 with the order or failure to submit a timely report.

24 (f) If after a hearing, the Commissioner finds that the employment agency
25 has violated the provisions of this section, the Commissioner may impose a civil
26 penalty of not less than \$500 and not more than \$1,000 for each violation of this
27 section.]

3 **EMPLOYEE.**

4 **[(3)] (4)** The Commissioner may investigate whether § 3-710 of this
5 title has been violated on receipt of a written complaint of an employee as provided in
6 § 3-710(d)(1) of this title.

7 **(5) THE COMMISSIONER MAY INVESTIGATE WHETHER § 3-711 OF**
8 **THIS TITLE HAS BEEN VIOLATED ON RECEIPT OF A WRITTEN COMPLAINT OF AN**

17 (a) (1) In this section the following words have the meanings indicated.

18 (2) “Managerial employee” means an employee who:

19 (i) is not covered by a collective bargaining agreement;

20 (ii) as primary duty of the employee, manages an enterprise or a
21 unit of the enterprise that customarily is considered a department or subdivision of
22 the enterprise;

23 (iii) customarily and regularly supervises at least 2 other
24 employees in the enterprise or unit;

25 (iv) customarily and regularly exercises discretionary powers;
26 and

27 (v) may hire or fire another employee or makes
28 recommendations that affect the hiring, advancement, firing, or any other change in
29 status of another employee.

1 (3) “Part–time employee” means an employee who is employed for a
2 workweek of less than 25 hours.

3 (4) “Professional employee” means an employee whose primary duty is
4 to work in a field that requires advanced knowledge that customarily is acquired by a
5 prolonged course of specialized instruction and study.

6 (b) (1) This subsection does not apply during an emergency that a federal,
7 State, or local governmental authority declares.

8 (2) An employee in a retail establishment may choose, as a day of rest,
9 Sunday or the sabbath of the employee unless:

10 (i) outside Wicomico County, the employee is a managerial
11 employee, professional employee, or part–time employee; and

12 (ii) in Wicomico County, the employee is a managerial employee
13 or professional employee.

14 (3) An employee who chooses a day of rest:

15 (i) shall give written notice to the employer; and

16 (ii) during the course of employment, may change the day of rest
17 by giving written notice of the change to the employer at least 30 days before its
18 effective date.

19 (c) (1) This subsection does not apply to a managerial employee or
20 professional employee or, outside Wicomico County, a part–time employee.

21 (2) If an employer compels an employee to work on the day of rest that
22 the employee chooses under subsection (b) of this section, the employee is entitled to
23 bring an action against the employer to recover 3 times the regular rate of pay of the
24 employee for each hour the employee works on that day.

25 (d) This section may not be applied to abridge any right that a collective
26 bargaining agreement grants to a part–time employee or other employee.

27 (e) This section does not affect the laws that relate to:

28 (1) the sale of alcoholic beverages on Sunday; or

29 (2) service of process on Sunday.

30 (f) An employer may not:

1 (1) discharge, discipline, discriminate against, or otherwise penalize
2 an employee who chooses a day of rest; or

3 (2) require an applicant for employment who seeks a workweek of at
4 least 25 hours to answer any question to identify the day that the applicant chooses as
5 a day of rest.

6 **(G) (1) WHENEVER THE COMMISSIONER DETERMINES THAT THIS**
7 **SECTION HAS BEEN VIOLATED, THE COMMISSIONER ~~MAY~~ SHALL:**

8 **(I) TRY TO RESOLVE ANY ISSUE INVOLVED IN THE**

19 (2) Outside Wicomico County, an employer who violates any provision
20 of this section is guilty of a misdemeanor and on conviction is subject to a fine of not
21 less than \$250 or more than \$500.

22 (3) In Wicomico County, a person who violates any provision of this
23 section is guilty of a misdemeanor and on conviction, for each employee who is caused,
24 directed, permitted, or authorized to work:

25 (i) for a first conviction, is subject to a fine not exceeding \$500;
26 and

27 (ii) for a second conviction, is subject to a fine not exceeding
28 \$1,000.

29 **[(h)] (I)** In Wicomico County, the State's Attorney may file a complaint to
30 enjoin a violation of this section.

5 (a) (1) In this section the following words have the meanings indicated.

6 (2) "Applicant" means an applicant for employment.

7 (3) (i) "Electronic communications device" means any device that
8 uses electronic signals to create, transmit, and receive information.

9 (ii) "Electronic communications device" includes computers,
10 telephones, personal digital assistants, and other similar devices.

11 (4) (i) "Employer" means:

12 1. a person engaged in a business, an industry, a
13 profession, a trade, or other enterprise in the State; or

14 2. a unit of State or local government.

15 (ii) "Employer" includes an agent, a representative, and a
16 designee of the employer.

17 (b) (1) Subject to paragraph (2) of this subsection, an employer may not
18 request or require that an employee or applicant disclose any user name, password, or
19 other means for accessing a personal account or service through an electronic
20 communications device.

21 (2) An employer may require an employee to disclose any user name,
22 password, or other means for accessing nonpersonal accounts or services that provide
23 access to the employer's internal computer or information systems.

24 (c) An employer may not:

25 (1) discharge, discipline, or otherwise penalize or threaten to
26 discharge, discipline, or otherwise penalize an employee for an employee's refusal to
27 disclose any information specified in subsection (b)(1) of this section; or

28 (2) fail or refuse to hire any applicant as a result of the applicant's
29 refusal to disclose any information specified in subsection (b)(1) of this section.

30 (d) An employee may not download unauthorized employer proprietary
31 information or financial data to an employee's personal Web site, an Internet Web site,
32 a Web-based account, or a similar account.

1 (e) This section does not prevent an employer:

2 (1) based on the receipt of information about the use of a personal Web
3 site, Internet Web site, Web-based account, or similar account by an employee for
4 business purposes, from conducting an investigation for the purpose of ensuring
5 compliance with applicable securities or financial law, or regulatory requirements; or

6 (2) based on the receipt of information about the unauthorized
7 downloading of an employer's proprietary information or financial data to a personal
8 Web site, Internet Web site, Web-based account, or similar account by an employee,
9 from investigating an employee's actions under subsection (d) of this section.

20 (a) (1) In this section, "employer" means a person engaged in a business,
21 industry, profession, trade, or other enterprise in the State.

22 (2) "Employer" includes:

23 (i) a unit of State or local government that employs individuals
