A BILL ENTITLED

1 AN ACT concerning

2 **Human Relations – Housing Discrimination – Source of Income**

3 FOR the purpose of expanding the housing policy of the State to include providing for
4 fair housing to all citizens regardless of source of income; prohibiting a person
5 from refusing to sell or rent a dwelling to any person because of source of
6 income; establishing certain qualifications and limitations on the general
7 prohibition against discrimination in housing based on source of income;
8 prohibiting a person from discriminating against any person in the terms,
9 conditions, or privileges of the sale or rental of a dwelling because of source of
10 income; prohibiting a person from making, printing, or publishing certain types
11 of materials with respect to the sale or rental of a dwelling that indicate a
12 preference, limitation, or discrimination on the basis of source of income;
13 prohibiting a person from falsely representing that a dwelling is not available
14 for inspection, sale, or rental based on source of income; prohibiting a person
15 from inducing or attempting to induce, for profit, a person to sell or rent a
16 dwelling by making certain representations relating to the entry or prospective
17 entry into the neighborhood of a person having a particular source of income;
18 prohibiting a person whose business includes engaging in residential real estate
19 transactions from discriminating against any person in making available a
20 transaction, or in the terms or conditions of a transaction, because of source of
21 income; prohibiting a person from denying a person, based on source of income,
22 access to, or membership or participation in, a service, organization, or facility
23 relating to the business of selling or renting dwellings, or discriminating against
24 a person in the terms or conditions of membership or participation; prohibiting
25 a person from, by force or threat of force, willfully injuring, intimidating, or
26 interfering with any person because of source of income and because the person
27 is negotiating for the sale or rental of any dwelling or participating in any
28 service relating to the business of selling or renting dwellings; defining a certain
29 term; providing that certain provisions concerning source of income do not apply

1 to certain housing; providing that this Act does not limit the rights or remedies
 2 that are otherwise available to a landlord or tenant under any other law;
 3 requiring the Department of Housing and Community Development to evaluate
 4 the effectiveness of this Act in achieving its goals and to submit an interim
 5 report on the findings and recommendations of the Department to the Governor
 6 and the General Assembly on or before a certain date; requiring the Department
 7 to submit a final report on its findings and recommendations to the Governor
 8 and the General Assembly on or before a certain date; and generally relating to
 9 prohibitions against discrimination in housing based on source of income.

15 Preamble

16 WHEREAS, The General Assembly recognizes that equality, fairness, and
 17 opportunity for Maryland residents often require government action and that security,
 18 mobility, and economic opportunity are enhanced by the location of a person’s home;
 19 and

20 WHEREAS, Discrimination in housing based on a person’s source of income
 21 primarily affects persons that the General Assembly has already determined to need
 22 legal protection from discrimination such as families with children, people of color, and
 23 people with disabilities; and

24 WHEREAS, Eleven states, including Connecticut, Maine, Massachusetts,
 25 Minnesota, New Jersey, North Dakota, Oklahoma, Oregon, Utah, Vermont, and
 26 Wisconsin, the District of Columbia, and over 30 localities across the country have
 27 laws prohibiting discrimination based on a person’s source of income; and

28 WHEREAS, This Act will not prevent private landlords from considering
 29 relevant, nondiscriminatory factors in screening rental applicants, including an
 30 applicant’s ability to comply with lease terms and prior tenancy history; and

31 WHEREAS, This Act seeks to deconcentrate poverty by providing additional
 32 opportunities for tenants utilizing public subsidies to live in neighborhoods other than
 33 the neighborhoods in which those individuals are currently and disproportionately
 34 residing; now, therefore,

35 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 36 MARYLAND, That the Laws of Maryland read as follows:

37 Article – State Government

1 20–701.

2 (a) In this subtitle the following words have the meanings indicated.

3 (b) (1) “Disability” means:

4 (i) a physical or mental impairment that substantially limits
5 one or more of an individual’s major life activities;

6 (ii) a record of having a physical or mental impairment that
7 substantially limits one or more of an individual’s major life activities; or

8 (iii) being regarded as having a physical or mental impairment
9 that substantially limits one or more of an individual’s major life activities.

10 (2) “Disability” does not include the current illegal use of or addiction
11 to:

12 (i) a controlled dangerous substance, as defined in § 5–101 of
13 the Criminal Law Article; or

14 (ii) a controlled substance, as defined in 21 U.S.C. § 802.

15 (c) “Discriminatory housing practice” means an act that is prohibited under §
16 20–705, § 20–706, § 20–707, or § 20–708 of this subtitle.

17 (d) “Dwelling” means:

18 (1) any building, structure, or portion of a building or structure that is
19 occupied, or designed or intended for occupancy, as a residence by one or more
20 families; and

21 (2) any vacant land that is offered for sale or lease for the construction
22 or location on the land of any building, structure, or portion of a building or structure
23 described in item (1) of this subsection.

24 (e) (1) “Familial status” means the status of one or more minors who are
25 domiciled with:

26 (i) a parent or other person having legal custody of the minor;
27 or

28 (ii) the designee of a parent or other person having legal custody
29 of the minor with the written permission of the parent or other person.

30 (2) “Familial status” includes the status of being:

- 1 (i) a pregnant woman; or
2 (ii) an individual who is in the process of securing legal custody
3 of a minor.

4 (f) “Family” includes a single individual.

5 (g) “In the business of selling or renting dwellings” means:

6 (1) within the preceding 12 months, participating as a principal in
7 three or more transactions involving the sale or rental of any dwelling or any interest
8 in a dwelling;

9 (2) within the preceding 12 months, participating as an agent, other
10 than in the sale of the individual’s own personal residence, in providing sales or rental
11 facilities or services in two or more transactions involving the sale or rental of any
12 dwelling or any interest in a dwelling; or

13 (3) being the owner of any dwelling occupied, or designed or intended
14 for occupancy, by five or more families.

15 (h) “Marital status” means the state of being single, married, separated,
16 divorced, or widowed.

17 (i) “Rent” includes to lease, sublease, let, or otherwise grant for a
18 consideration the right to occupy premises not owned by the occupant.

19 **(J) (1) “SOURCE OF INCOME” MEANS ANY LAWFUL SOURCE OF**
20 **MONEY PAID DIRECTLY OR INDIRECTLY TO, OR ON BEHALF OF, A RENTER OR**
21 **BUYER OF HOUSING.**

22 **(2) “SOURCE OF INCOME” INCLUDES INCOME FROM:**

23 **(I) A LAWFUL PROFESSION, OCCUPATION, OR JOB;**

24 **(II) ANY GOVERNMENT OR PRIVATE ASSISTANCE, GRANT,**
25 **LOAN, OR RENTAL ASSISTANCE PROGRAM, INCLUDING LOW-INCOME HOUSING**
26 **ASSISTANCE CERTIFICATES AND VOUCHERS ISSUED UNDER THE UNITED**
27 **STATES HOUSING ACT OF 1937;**

28 **(III) A GIFT, AN INHERITANCE, A PENSION, AN ANNUITY,**
29 **ALIMONY, CHILD SUPPORT, OR OTHER CONSIDERATION OR BENEFIT; OR**

30 **(IV) THE SALE OR PLEDGE OF PROPERTY OR AN INTEREST IN**
31 **PROPERTY.**

1 20-702.

2 (a) It is the policy of the State:

3 (1) to provide for fair housing throughout the State to all, regardless of
4 race, color, religion, sex, familial status, national origin, marital status, sexual
5 orientation, [or] disability, **OR SOURCE OF INCOME**; and

6 (2) to that end, to prohibit discriminatory practices with respect to
7 residential housing by any person, in order to protect and insure the peace, health,
8 safety, prosperity, and general welfare of all.

9 (b) This subtitle:

10 (1) is an exercise of the police power of the State for the protection of
11 the people of the State; and

12 (2) shall be administered and enforced by the Commission and, as
13 provided in this title, enforced by the appropriate State court.

14 20-704.

15 (a) This subtitle does not apply to:

16 (1) the sale or rental of a single-family dwelling, if the dwelling is sold
17 or rented without:

18 (i) the use of the sales or rental facilities or services of any:

19 1. real estate broker, agent, or salesperson;

20 2. agent of any real estate broker, agent, or salesperson;

21 3. person in the business of selling or renting dwellings;

22 or

23 4. agent of a person in the business of selling or renting
24 dwellings; or

25 (ii) the publication, posting, or mailing, after notice, of any
26 advertisement or written notice in violation of this subtitle; and

27 (2) with respect to discrimination on the basis of sex, sexual
28 orientation, [or] marital status, **OR SOURCE OF INCOME, IF THE SOURCE OF**
29 **INCOME IS RENTAL ASSISTANCE**:

1 (i) the rental of rooms in any dwelling, if the owner maintains
2 the dwelling as the owner's principal residence; or

3 (ii) the rental of any apartment in a dwelling that contains not
4 more than five rental units, if the owner maintains the dwelling as the owner's
5 principal residence.

6 (b) The use of attorneys, escrow agents, abstractors, title companies, and
7 other similar professional assistance as necessary to perfect or transfer the title to a
8 single-family dwelling does not subject a person to this subtitle if the person otherwise
9 would be exempted under subsection (a) of this section.

10 (c) (1) (i) In this subsection, "housing for older persons" means
11 housing:

12 1. provided under any State or federal program that is
13 specifically designed and operated to assist elderly persons, as defined in the State or
14 federal program;

15 2. intended for, and solely occupied by, persons who are
16 at least 62 years old;

17 3. intended and operated for occupancy by at least one
18 person who is at least 55 years old in each unit; or

19 4. that meets the requirements set forth in regulations
20 adopted by the Secretary of Housing and Urban Development under 42 U.S.C. §
21 3607(b)(2)(C).

22 (ii) "Housing for older persons" includes:

23 1. unoccupied units, if the units are reserved for
24 occupancy by persons who meet the age requirements of subparagraph (i) of this
25 paragraph; or

26 2. units occupied as of September 13, 1988 by persons
27 who do not meet the age requirements of subparagraph (i) of this paragraph, if the
28 new occupant of the unit meets the age requirement.

29 (2) The provisions in this subtitle concerning familial status do not
30 apply to housing for older persons.

31 **(D) (1) IN THIS SUBSECTION, "ASSISTED RENTAL HOUSING**
32 **DEVELOPMENT" MEANS A DEVELOPMENT CONSISTING OF FOUR OR MORE**
33 **CONTIGUOUS RENTAL UNITS IN WHICH 20% OR MORE OF THE UNITS ARE**
34 **REQUIRED TO BE RENTED TO HOUSEHOLDS WITH AN INCOME THAT DOES NOT**

1 EXCEED 50% OF THE AREA MEDIAN INCOME UNDER A FEDERAL, STATE, OR
2 LOCAL GOVERNMENT HOUSING ASSISTANCE PROGRAM.

3 (2) THE PROVISIONS OF THIS SUBTITLE CONCERNING
4 DISCRIMINATION ON THE BASIS OF SOURCE OF INCOME DO NOT APPLY TO THE
5 RENTAL OF A UNIT IN AN ASSISTED RENTAL HOUSING DEVELOPMENT IF THE
6 SOURCE OF INCOME IS RENTAL ASSISTANCE.

7 (E) THE PROHIBITIONS IN THIS SUBTITLE AGAINST DISCRIMINATION
8 BASED ON SOURCE OF INCOME DO NOT:

9 (1) PROHIBIT A PERSON FROM DETERMINING THE ABILITY OF A
10 POTENTIAL BUYER OR RENTER TO PAY A PURCHASE PRICE OR PAY RENT BY
11 VERIFYING, IN A COMMERCIALY REASONABLE AND NONDISCRIMINATORY
12 MANNER, THE SOURCE AND AMOUNT OF INCOME OF THE POTENTIAL BUYER OR
13 RENTER; OR

14 (2) PREVENT A PERSON FROM REFUSING TO CONSIDER INCOME
15 DERIVED FROM ANY CRIMINAL ACTIVITY.

16 20–705.

17 Except as provided in §§ 20–703 and 20–704 of this subtitle, a person may not:

18 (1) refuse to sell or rent after the making of a bona fide offer, refuse to
19 negotiate for the sale or rental of, or otherwise make unavailable or deny, a dwelling to
20 any person because of race, color, religion, sex, disability, marital status, familial
21 status, sexual orientation, [or] national origin, OR SOURCE OF INCOME;

22 (2) discriminate against any person in the terms, conditions, or
23 privileges of the sale or rental of a dwelling, or in the provision of services or facilities
24 in connection with the sale or rental of a dwelling, because of race, color, religion, sex,
25 disability, marital status, familial status, sexual orientation, [or] national origin, OR
26 SOURCE OF INCOME;

27 (3) make, print, or publish, or cause to be made, printed, or published,
28 any notice, statement, or advertisement with respect to the sale or rental of a dwelling
29 that indicates any preference, limitation, or discrimination based on race, color,
30 religion, sex, disability, marital status, familial status, sexual orientation, [or]
31 national origin, OR SOURCE OF INCOME, or an intention to make any preference,
32 limitation, or discrimination;

33 (4) represent to any person, because of race, color, religion, sex,
34 disability, marital status, familial status, sexual orientation, [or] national origin, OR

1 **SOURCE OF INCOME**, that any dwelling is not available for inspection, sale, or rental
2 when the dwelling is available; or

3 (5) for profit, induce or attempt to induce any person to sell or rent
4 any dwelling by representations regarding the entry or prospective entry into the
5 neighborhood of a person of a particular race, color, religion, sex, disability, marital
6 status, familial status, sexual orientation, [or] national origin, **OR SOURCE OF**
7 **INCOME**.

8 20–707.

9 (a) In this section, “residential real estate–related transaction” means:

10 (1) the making or purchasing of loans or providing other financial
11 assistance:

12 (i) for purchasing, constructing, improving, repairing, or
13 maintaining a dwelling; or

14 (ii) secured by residential real estate; or

15 (2) the selling, brokering, or appraising of residential real property.

16 (b) (1) A person whose business includes engaging in residential real
17 estate–related transactions may not discriminate against any person in making
18 available a transaction, or in the terms or conditions of a transaction, because of race,
19 color, religion, sex, disability, marital status, familial status, sexual orientation, [or]
20 national origin, **OR SOURCE OF INCOME**.

21 (2) Paragraph (1) of this subsection does not prohibit a person engaged
22 in the business of furnishing appraisals of real property from taking into consideration
23 factors other than race, color, religion, sex, disability, marital status, familial status,
24 sexual orientation, [or] national origin, **OR SOURCE OF INCOME**.

25 (c) A person may not, because of race, color, religion, sex, disability, marital
26 status, familial status, sexual orientation, [or] national origin, **OR SOURCE OF**
27 **INCOME**:

28 (1) deny a person access to, or membership or participation in, a
29 multiple–listing service, real estate brokers’ organization, or other service,
30 organization, or facility relating to the business of selling or renting dwellings; or

31 (2) discriminate against a person in the terms or conditions of
32 membership or participation.

33 20–1103.

1 (a) In this section, “disability”, “dwelling”, “familial status”, “marital status”,
2 [and] “rent”, AND “SOURCE OF INCOME” have the meanings stated in § 20–701 of
3 this title.

4 (b) Whether or not acting under color of law, a person may not, by force or
5 threat of force, willfully injure, intimidate, interfere with, or attempt to injure,
6 intimidate, or interfere with:

7 (1) any person because of race, color, religion, sex, disability, marital
8 status, familial status, sexual orientation, [or] national origin, OR SOURCE OF
9 INCOME and because the person is or has been:

10 (i) selling, purchasing, renting, financing, occupying, or
11 contracting or negotiating for the sale, purchase, rental, financing, or occupation of
12 any dwelling; or

13 (ii) applying for or participating in any service, organization, or
14 facility relating to the business of selling or renting dwellings;

15 (2) any person because the person is or has been, or in order to
16 intimidate the person or any other person or any class of persons from:

17 (i) participating, without discrimination on account of race,
18 color, religion, sex, disability, marital status, familial status, sexual orientation, [or]
19 national origin, OR SOURCE OF INCOME, in any of the activities, services,
20 organizations, or facilities described in item (1) of this subsection; or

21 (ii) affording another person or class of persons the opportunity
22 or protection to participate in any of the activities, services, organizations, or facilities
23 described in item (1) of this subsection; or

24 (3) any person because the person is or has been, or in order to
25 discourage the person or any other person from:

26 (i) lawfully aiding or encouraging other persons to participate,
27 without discrimination on account of race, color, religion, sex, disability, marital
28 status, familial status, sexual orientation, [or] national origin, OR SOURCE OF
29 INCOME, in any of the activities, services, organizations, or facilities described in item
30 (1) of this subsection; or

31 (ii) participating lawfully in speech or peaceful assembly
32 opposing any denial of the opportunity to participate in any of the activities, services,
33 organizations, or facilities described in item (1) of this subsection.

1 (c) A person who violates this section is guilty of a misdemeanor and on
2 conviction is subject to:

3 (1) imprisonment not exceeding 1 year or a fine not exceeding \$1,000
4 or both;

5 (2) if the violation results in bodily injury, imprisonment not
6 exceeding 10 years or a fine not exceeding \$10,000 or both; or

7 (3) if the violation results in death, imprisonment not exceeding life.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act does not limit
9 the rights or remedies that otherwise are available to a landlord or tenant under any
10 other law.

11 SECTION 3. AND BE IT FURTHER ENACTED, That:

12 (1) On or before December 31, 2018, the Department of Housing and
13 Community Development shall evaluate the effectiveness of this Act in achieving its
14 goals and submit an interim report on the findings and recommendations of the
15 Department to the Governor and, in accordance with § 2-1246 of the State
16 Government Article, the General Assembly.

17 (2) On or before December 31, 2020, the Department of Housing and
18 Community Development shall evaluate the effectiveness of this Act in achieving its
19 goals and submit a final report on the findings and recommendations of the
20 department to the Governor and, in accordance with § 2-1246 of the State
21 Government Article, the General Assembly.

22 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2013.
