## CHAPTER \_\_\_\_\_

1 AN ACT concerning

### 2 **State Brain Injury Trust Fund**

3 FOR the purpose of establishing the State Brain Injury Trust Fund as a special fund  
4 to be used to support certain services for certain individuals with brain injuries;  
5 requiring the Secretary of Health and Mental Hygiene or the Secretary's  
6 designee to administer the Fund; requiring the Secretary or the Secretary's  
7 designee to report to the Governor and the General Assembly on or before a  
8 certain date each year; establishing eligibility for individuals to receive  
9 assistance from the Fund; requiring that certain investment earnings be  
10 credited to the Fund; ~~altering the amount of a certain motor vehicle registration~~  
11 ~~fee surcharge; requiring that a certain amount of the motor vehicle registration~~  
12 ~~fee surcharge be paid into the Fund;~~ requiring the  
13 Department of Health and Mental Hygiene to report to the General Assembly on

 32 MARYLAND, That the Laws of Maryland read as follows:

11           **(B) (1) THE PURPOSE OF THE FUND IS TO ASSIST IN THE PROVISION**

6           (C) THE SECRETARY OR THE SECRETARY'S DESIGNEE SHALL  
7 ADMINISTER THE FUND.

8           (D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT  
9 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

10           (2) THE STATE TREASURER SHALL HOLD THE FUND  
11 SEPARATELY, AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

12           (E) THE FUND CONSISTS OF:

13           (1) ~~MOTOR VEHICLE REGISTRATION SURCHARGES PAID INTO THE~~  
14 ~~FUND IN ACCORDANCE WITH § 13-954(B)(3) OF THE TRANSPORTATION~~

20           (F) THE FUND MAY BE USED ONLY TO PROVIDE FUNDING FOR THE  
21 PURPOSE DESCRIBED IN SUBSECTION (B) OF THIS SECTION.

22           (G) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE  
23 FUND IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

24           (2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE  
25 CREDITED TO THE FUND.

26           (H) MONEY EXPENDED FROM THE FUND TO SUPPORT SERVICES TO  
27 INDIVIDUALS WITH BRAIN INJURIES IS SUPPLEMENTAL TO AND IS NOT

1 INTENDED TO TAKE THE PLACE OF FUNDING THAT WOULD OTHERWISE BE  
2 APPROPRIATED FOR THOSE SERVICES.

3 (I) ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE SECRETARY OR  
4 THE SECRETARY'S DESIGNEE SHALL SUBMIT A REPORT TO THE GOVERNOR  
5 AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE,  
6 THE GENERAL ASSEMBLY ON THE NUMBER OF INDIVIDUALS SERVED AND THE  
7 SERVICES PROVIDED IN THE PRECEDING FISCAL YEAR USING THE FUND.

9 (A) TO BE ELIGIBLE FOR ASSISTANCE FROM THE FUND, AN INDIVIDUAL  
10 SHALL:

11 (1) BE A UNITED STATES CITIZEN AND A RESIDENT OF THE  
12 STATE AT THE TIME OF THE BRAIN INJURY;

13 (2) HAVE A BRAIN INJURY THAT HAS BEEN DOCUMENTED IN THE  
14 MEDICAL RECORDS OF THE INDIVIDUAL;

15 (3) HAVE INCOME AT OR BELOW 300% OF THE FEDERAL POVERTY  
16 LEVEL; AND

17 (4) HAVE EXHAUSTED ALL OTHER HEALTH, REHABILITATION,  
18 AND DISABILITY BENEFIT FUNDING SOURCES THAT COVER THE SERVICES  
19 PROVIDED BY THE FUND.

20 (B) AN INDIVIDUAL MAY NOT RECEIVE SERVICES FROM THE FUND  
21 COSTING MORE THAN:

22 (1) THE ANNUAL AMOUNT ESTABLISHED BY POLICIES AND  
23 PROCEDURES ADOPTED BY THE SECRETARY OR THE SECRETARY'S DESIGNEE;  
24 AND

25 (2) THE LIFETIME OF THE INDIVIDUAL AMOUNT ESTABLISHED BY  
26 POLICIES AND PROCEDURES ADOPTED BY THE SECRETARY OR THE  
27 SECRETARY'S DESIGNEE.

11           SECTION 2. AND BE IT FURTHER ENACTED, That, on or before January 1,  
12 2014, the Department of Health and Mental Hygiene shall report to the General  
13 Assembly, in accordance with § 2-1246 of the State Government Article, on:

14           (1) the expected date of implementation of Section 1 of this Act;

15           (2) the status of adoption of any rules or procedures relating to the  
16 administration of the Fund established under Section 1 of this Act; and

17           (3) any recommendations for legislation needed to allow for more  
18 efficient administration of the Fund established under Section 1 of this Act.

19           SECTION 3. AND BE IT FURTHER ENACTED, That the Department of  
20 Health and Mental Hygiene may contract with an outside entity to develop the rules  
21 and procedures relating to the administration of the Fund established under Section 1  
22 of this Act.

23           SECTION 4. AND BE IT FURTHER ENACTED, That it is the intent of the  
24 General Assembly that implementation of administration of the Fund begin on or after  
25 July 1, 2014.
